Anna M. Loman and Chester Loman her husband. Frank Harkness. Emma keys and William B Keys her husband, Harriet Cunningham and James F. Cunningham her husband, George C. Corning and Warren H. Corning defendants and numbered on Docket No. 61008 paying them among other things for the title of certain real estate in said petition set out and thereafter decreed by the Court and for petition of same among the owners. according to their several intents and for relief. And whereas afterwards to wit on February 20th 1880 Robert Fosdick, Henry Fosdick, Sylvester Fosdick, Mrs. Fosdick widow of Sylverster M. Fosdick deceased. Anna Douglass, Minnie Douglass and Lizzie Douglass were made parties defendant in said case and whereas afterwards to wit on the 2nd day of August 1880 the death of said Jane Gans was suggested to the Court and therefore the court ordered that the said action stand in the names of Charles L. Gans, Ella G. Iglehart and Nicolas G. Iglehart her husband. Mary Mussey and R.D. Mussey her husband, Fannie B. Spinning, and Charles P. Spinning her husband, Lida G. Koehler and R.H. Koebler her husband, Charles L. Gans, jr and Walter W. Gans minor and that they be permitted to prosecute the same as the representatives of Jane Gans and as decreed under the will of Anthony Harkness and therefore said parties appeared and filed supplemental petitions in said case. And whereas afterwards to wit on the 7th day of October in 1880 the May term of the Common Pleas Court a judgment was entered by the court in said case whereby it was adjudged that George C. Corning and Warren H. Corning had forfeited the title to the persons next entitled to said lands thereafter found all the estates which they or either of them held by courtesy George C. Corning and transferred to Warren H. Corning had ceased to exist and that the title to said premises had passed to persons next entitled to the same and that such persons had lawfully entered into and were in possessionIt was further adjudged and decreed that Robert Fosdick, Henry Fosdick and Sylvester Fosdick, Anna Douglass Minnie Douglass and Lizzie Douglass were each had a legal right to to the undivided one fifty fourth part of said premises and that Harriet Cunningham, Frank Harkness, Emma D. Keys, Ella G Iglehart, Mary H. Mussey, Fanny Spinning, Lida G. Koehler, Charles H. Gans jr and Walter W. Gans and Kate Woodmanse, Louisa Poor, Alice Loman

and Anthony H King, Charles G. King, William O. King and Anna Loman each had a legal right to the undivided eighteen part thereof and ordering that partition be made of said estate. (A sheriff was appointed to see to the division. It was found that the premises could not be divided without incurring injury to the value of the estate therefore that they appraise the same whereas on the 7 day of October 1880 an order for partition was issued to the sheriff of said county commanding him to cause partition to be made according to the order of said Court and where as on November 15 1880 made return of said writ of partition with the report of the commission reporting Whereas afterwards on November 28 an order was made that said premises be sold at public auction. And whereas afterward on the 29 day of November in pursuance of said order and judgment of the court and forwarded thereon an order of sale issued from said court and in cause directed to George Weber, sheriff of Hamilton County commanding him to execute the said order.....Whereas the said George Weber, aforesaid, having advertised the time and place of selling the same in the Cincinnati Daily Enquirer, a newspaper printed and of general circulation for a period of thirty day prior to the day of sale.....The successor in office Samuel Bailey did on the 8th day of January on the premises at 10 o'clock expose to sale at public auction the premises hereafter mentioned and therefore Mary H. Mussey did bid the sum of seventy one hundred and thirty five dollars which said sum being the highest and last bid offered for the same and more than two thirds of the appraised value thereof. The said premises were then and there struck off to her the said Mary H. Mussey.....the sheriff should convey to same by deed in fee simple to the purchaser Mary H. Mussey.....all of the following real estate to wit all those certain lots and parcels....all of lot 76 and 77 in Block 10 in the town of Glendale and being the Mansion House of Anthony Harkness described together with all the privileges and appurtenances
