Note: The house on this lot was moved from the property located at 800 Ivy Avenue, which was owned at the time of this deed by Herman W. Lackman. The building has been referred to as the Lackman Estate Carriage House. The structure was moved down the hill from Ivy Avenue through an open lot that is now 170 Magnolia Avenue to its present location on Woodbine. The date of that move is not known. The house at 800 Ivy Avenue was built in 1865, but there is no record of the actual date this carriage house was built. Herman Lackman sold his home to Charlotte Smith on October 30, 1925. On March 23, 1926, Charlotte Smith sold the house located at 800 Ivy Avenue to John Stewart and the house was moved to 740 Woodbine Avenue. The actual move began in the summer of 1926 and was completed on February 2, 1927. Charlotte Smith built the house that is currently at 800 Ivy Avenue in 1927.

Assessment of the age of the house.

The records on the Hamilton County website indicate that the house at 810 Woodbine Avenue was built in 1927 and I agree with this date. It may be that the structure became a house in that year, but if the structure was originally located on the property at 800 Ivy Avenue, it is likely it was built before then. The original house at 800 Ivy was built in 1865. It would seem plausible that a carriage house would have been built around the same time. An essay for the Monday Group written in 1972 bt Angeline Faran and titled Houses That Moved contains the following excerpt. "The Lackman Carriage House, at the back of the Lackman property, was later moved from the Ivy Avenue lot to become the Edgar Moesers' home at 810 Woodbine....The building came down the lot, across the street, through the open lot where the Dick Keys' house now stands, back of the little cottage, to its present position." Since this occurred after the move of the house at 800 Ivy Avenue, which was begun in 1926 and completed in 1927, it seems that Charlotte Smith also sold the carriage house to the Moesers' in 1926 with the renovation of the carriage house completed in 1927. There are architectural plans for Edgar Moeser, Esq. in the museum, done by Stanley Matthews, showing the outline of a carriage house. The plans are not dated.
