

THE LAST WILL AND TESTAMENT

OF George Fleischer, a single man of the Township of Bohnsack, in the County of Traill and State of North Dakota made and published the 27th day of November, in the year of our Lord one thousand Nine Hundred and Fifty-seven.

I, George Fleischer, a single man of the Township of Bohnsack, in the County of Traill and State of North Dakota, of the age of Eighty-three years, and being of sound mind and memory, do hereby make, publish and declare this my LAST WILL AND TESTAMENT, in the manner following, that is to say:

FIRST- It is my will that my funeral expenses and all my just debts be fully paid.

SECOND- I order and direct that my Executor hereinafter named, be authorized and directed to pay out of my estate all inheritance, legacy, or estate taxes on my Estate, and that they do not be deducted from the share of any beneficiary hereunder.

THIRD- I order and direct that my body be buried in my burial lot, described as the West Half of Block Twenty-three (23) Hillsboro Cemetery, Traill Co. North Dakota.

FOURTH- I further order and direct that my Executor, sell and convert into cash my real estate described as the Northeast Quarter (NE $\frac{1}{4}$) of Section Twenty-six (26), in Township One Hundred Forty-four (144) North, Range Fifty-one (51), West of the Fifth Principal Meridian, in Traill County, State of North Dakota and also convert all my personal property, including the United States Bonds, so that all my property will be in cash for the purpose of final Distribution, and this done without Petition or Order.

FIFTH- I give, devise and bequeath all the residue of my Estate, after the payment of all costs of administration to the following named Institutions, Organizations, and Heirs on a Percentage basis, to-wit:

The Hillsboro Community Hospital, Hillsboro, North Dakota	-----	Five (5) Percent.
The Presbyterian Church, situated at Grandin, Cass Co. N. Dak.	-----	One (1) percent.
The Crippled Children's Home, at Jamestown, North Dakota	-----	Two (2) Percent.
The Sister Kenny Foundation (Polio) Minneapolis, Minnesota	-----	Two (2) Percent.

LASTLY-- I hereby nominate and appoint C. L. Ferguson of Hillsboro, North Dakota, to be the Executor of this my LAST WILL AND TESTAMENT, hereby revoking all former Wills by me made, and I request and direct that he be allowed to qualify without furnishing any bond.
