Mr. Mahoney, of Averill Park, advises that the hotel keeper near the dike on Burden Lake wishes to raise the bridge in the dike, at his own expense, so that boats could pass under it. Ex-Surrogate McChesney has also stated that he would contribute part of the expense, if necessary.

As the bridge now is, it is too low to permit of boats going under it, so they have to be hauled over the dike and break down the fence more or less every summer.



The next order of business being the election of officers, motion was made by Mr. Dereski, seconded by M. G. Maloney, a vote was taken and carried unanimously that the following officers be elected to serve for the ensuing year:

Motion was made by M. G. Maloney, seconded by Mr. Dereski that the salary of Secretary-Treasurer be fixed at the rate of \$25.00 per month.

Mr. P. M. Dereski and Mr. M. G. Maloney of the Auditing Committee reported that an examination was made of the Treasurer's accounts for the year 1969 and found them correctly kept and satisfactorily vouched for all payments. Upon motion, the report was accepted and ordered placed on file.

The Chair appointed Mr. Dereski and Mr. Maloney as the Auditing Committee to make similar examination for the year 1970.

Mr. Maloney made a motion, seconded by Mr. Dereski that the annual assessment remain the same as last year, \$2,600.00 to be paid annually, as soon as possible after bills are sent out showing proportionate shares.

The Chairman reported to the meeting that repair work was necessary at Glass Lake. We would check with the Highway Department informing them about the bridge and we would get bidg from contractors on the washout of the road near the bridge.

Also it was agreed by both parties that if it became necessary to wngage the services of a Gatekeeper again it would be agreeable by both parties the salary to be fixed at \$50.00 per month as before.
