## **Project Abstract**

A reunion of veterans of the Civilian Conservation Corps and scholars will discuss the Great Depression and President Franklin D. Roosevelt's New Deal efforts to combat unemployment. The CCC, the most successful of Roosevelt's "Alphabet" agencies, proved to be the foundation for Louisiana's present timber industry and played an important role in preparations for WWII. Photographs of some remaining CCC structures will be on view. WWII.

The CCC "boys" are eager to tell younger generations how bad times were in the 1930's and what the CCC meant to them and their families. Scholars will put the CCC in historical perspective and point out how the program in the South differed from that in the West. The discussion program will be open to the public.

Special certificates will be presented to the CCC veterans
