## MEMBERS TO BE ASKED AT DINNER TO ENDORSE POLICY OF MOVING CLUBHOUSE

A resolution for moving the clubhouse to the western end of Aquatic Park will be read at the Old Timers Dinner and presented to the membership for signing.

The resolution, which has been drawn up by Ted Monell upon the instruction of the board of directors, will serve as a clear mandate to the board to pursue its efforts to obtain the site.

Old Timers will remember the ideal conditions which favored us when the Club was located at the foot of Van Ness Avenue. When the clubhouse was moved to the foot of Polk Street, conditions were less favorable but tolerable.

Since 1937, when the clubhouse was again moved to its present location to make room for the concrete bleachers and what is now the San Francisco Maritime Museum, we have faced a losing battle with wind, tide and sand.

According to our agreement with the city we were to be moved to our present "temporary location" until a "suitable location" could be found.

After 17 years in this "temporary location" the board feels it is now time for a determined policy to obtain its goal.

At present, Stan Rybicki and George DeGear are heading a work committee to repair our present dock and put cables and wench in working order. The money for these repairs is coming out of our dock fund.

It is generally agreed, however, whatever repairs are made on the dock will only be a temporary solution to our problem for we will be faced with the ground swells and choppy water which causes damage to our boating equipment; we will still be faced with the sand which sweeps and creeps under and around our dock, choking our very existence.
