**1980's Boatroom Floor** Drawing by Dan Osborne; no date. Scope included construction of new perimeter & pier footings, and installation of Douglas fir finish flooring. (No record of building permit on SF website.) Constructed by Dolphin Conrad von Blankenberg.

**1983 Seawall 01** Drawing by Dan Osborne, dated 11-16-83. Scope included construction of new wood piling seawall. (No record of building permit on SF website.) Constructed by Dolphin Conrad von Blankenberg.

1983 Seawall 02 + Site Plan + Security Fence Additional Dan Osborne seawall drawings.

**1984 Boathouse Addition** Design drawings by Zack Stewart, from 1984. Includes a "Dolphin Club Annex – Project Chronology". The first design for the boathouse addition.

**1987 Boathouse Addition** Revised design drawings, by Dan Osborne & Lee Hammack, dated 10-13-87.

**1987 Boat Layout** Colored rendering of proposed boat arrangement, by Dan Osborne, 1987.

**1988 Boathouse Addition** Approved permit drawings, dated 11-14-88, application no. 8818097; prepared by Dan Osborne & Lee Hammack. Scope included construction of the addition containing the boat storage annex & current women's locker room, on the footprint of the San Francisco Rowing, aka Ariel, Club. Constructed by Dolphin Conrad von Blankenberg.

**1989 Boathouse Addition Fire Sprinklers** by Potter Fire Protection Inc., dated 3/18/89.

**1991 BCDC Permit Documents** Drawings & other documents submitted to the Bay Conservation & Development Commission for permission to build the 1988 boathouse addition, dates vary, permit no. 1987.005.00. Scope included: required public signage, drinking fountain, shower, & benches; new security fence; and new transparent windbreak. Assembled from other sets of drawings – some duplicate drawings are included. (Location of originals is unknown.)

1991 Club Easements Survey By surveyor David M. Logan, dated December 20, 1991.

1994 Shower-Locker Room Expansion Phase 1 Progress Drawings developed for the shower-locker room expansion, no dates but produced in 1994. Sheet A3 has the 2d floor plan as it was before the remodel, and a plan of the proposed remodel that was dropped in favor of the current design (see 1994 Shower-Locker Room Expansion Phase 1, below). Sheet A6 describes parts of the building in section, as it was before the remodel, including the lightwell & locker space that was converted to the current men's shower & sauna. The

original no longer exists because it was cut up and pasted into the final shower-locker expansion phase 1 drawings (below).

1994 Shower-Locker Room Expansion Phase 1 Approved permit drawings, dated 21 Feb. 94, application no. 9421421; architectural drawings by Lee Hammack, structural drawings by Ralph Teyssier. Scope included construction of new men's shower & sauna in the area of the lightwell between the main boathouse building and the men's white locker rooms. Also included ground floor restroom & other access compliance remodel projects. Constructed by Dolphin Conrad von Blankenberg.

1997 Shower-Locker Room Expansion Phase 2 Approved permit drawings, dated 6 June 97, application no. 9421421; architectural drawings by Lee Hammack, structural drawings by Peter Van Maren. Scope included: the remodel of the boathouse addition second floor for the women's locker room, including new skylights; construction of new women's restroom, shower & sauna in the area of the former men's facilities; installation of a residential type elevator for access compliance; a ramp entry to the weight room; and other upgrades. Constructed by Roberts & Sons Builders.

**1999 Shower-Locker Room Expansion Phase 2 Shower Tiles** Diagram prepared by Lee Hammack, exact date unknown. Club members were given an opportunity to create personalized wall tiles, for a donation of \$500 per tile, to help cover the costs of Phase 2 of the renovation projects. The diagram was prepared to assist tile setters with placement of the personalized wall tiles

**2000 Shower-Locker Room Expansion Phase 3 – Part 1** Approved permit drawings, dated 1 Dec. 2000, application no. 2001/01/26/0690; architectural drawings by Lee Hammack, structural drawings by Peter Van Maren. Scope included remodel of the former women's locker-shower-sauna area for new men's lockers and other upgrades. Constructed by Dolphin Terry Keenan.

**2001 Shower-Locker Room Expansion Phase 3 – Part 2** Approved permit drawings, multiple dates, application no. 2001/09/10/7888; architectural drawings by Lee Hammack, structural drawings by Peter Van Maren. Scope included repair of deteriorated wall between DSBC & SERC and remodel area floor framing. Constructed by Dolphin Terry Keenan.

**2008 Dolphin Pier Pile Repair** Approved permit drawings, dated 03-19-08, application no. 2008/0331/8384; architectural drawings by Dan Osborne, structural drawings by Murphy-Burr-Curry. Scope included repair of existing pilings and replacement of deteriorated pier framing. Constructed by (confirm).

**2010 Women's Locker Replacement** Approved permit drawings, multiple dates, application no. 2010/0409/9985; drawing by Dan Osborne. Scope included replacement of women's locker room lockers. Assembled by Dolphin volunteers.

**2012 Staib Room Deck Repair** Structural drawings by Yadegar & Associates, dated 04/13/12; application no. 2012/0419/8722. Scope included construction of a new foundation for posts supporting the Staib Room deck. Constructed by Dolphin Peter van der Sterre.

2012 Security Fence Drawn by Anne Clark in 1992, revised 2012.

**2013 Rear Stair Repair** Approved permit drawings by Lee Hammack, dated 20 Mar. 2013; application no. 2013/0402/3577. Scope limited to repair of intermediate landing; construction by John Hornor.

**2013 Sauna Renovation** Approved permit drawings by Lee Hammack, dated 24 Oct. 2013; application no. 2013/1025/0233. Construction by John Hornor & Don Osborne.

**2019 BCDC Submittal** Prepared by Lee Hammack under direction of House Captain John Hornor; dated 21 Jan. 2019; for BCDC approval of maintenance of the pier, as required by BCDC.

**2019 Pier Repair - Cancelled** Prepared by Lee Hammack under direction of House Captain John Hornor; permit application form dated 3 July 2019 & drawings dated 27 Feb. 2019; for repair of the boat lift apron & BCDC required maintenance; application no. 2019-0703-5092; cancelled because the apron repair was not in SF Dept. of Bldg. Inspection jurisdiction.

**2019 Geometrix Survey PRELIM** Site survey prepared by Geometrix Surveying Engineering Inc. for the galley/weight room remodel projects; 1 sheet, dated 07-19-19. The survey is preliminary because it was not recorded with the San Francisco Assessor's office.

**2020 Access Compliance Reference Sheets** Copies of drawings demonstrating compliance with accessibility requirements for previous improvements; authors & dates vary; for attachment to building permit applications, to demonstrate compliance of existing facilities with CA Bldg. Code accessibility requirements.

**2020 Pier Repair - Approved** Drawings & attachments submitted to S.F. Port Authority for permit to repair the boat apron; drawings prepared by Lee Hammack & Archie Schachle under direction of House Captain John Hornor; dates vary – application approved June 4, 2020.
