

**OBV:**

Articles of Agreement made the twenty-fifth day of October, in the year of our Lord one thousand eight hundred and eighty nine.

Between Catherine Francis Small of the City of Toronto (~~the father~~ guardian) of the First Part Henry Campbell Small son of the said Catherine Francis Small of the Second Part, and Frederick William Kingstone of the said City of Toronto gentleman, one of the Solicitors of the Supreme Court of Judicature for Ontario, of the Third Part.

Witness, that the said Henry Campbell Small of his own free will (and with the consent and approbation of the said Catherine Francis Small testified by ~~his~~ execution of these presents). Hath placed and bound himself, and by these presents doth place and bind himself, clerk to the said Frederick William Kingstone to serve him from the day of the date hereof up to the day on which he shall be admitted as a student-at-law or entered as an articled clerk, whichever shall first happen in accordance with the rules of the Law Society, and during and until the full end and term of five years from the day of his so being admitted or entered then next ensuring:

And the said Catherine Francis Small doth hereby for ~~himself~~ herself, ~~him~~ her heirs, [...] executors, and administrators, covenant with the said Frederick William Kingstone his executors, administrators, and assigns, that the said Henry Campbell Small shall and will well, faithfully and diligently serve the said Frederick William Kingstone as his clerk in the practice or profession of a Solicitor of the Supreme Court from the date hereof during and until the full end of the hereinbefore mentioned term; And that the said Henry Campbell Small shall not, at any time, during suck term, cancel, obliterate, injure, spoil, destroy, waste, embezzle, spend, or make away with any of the books, papers, writings, documents, moneys, stamps, chattels, or other property of the said Frederick William Kingstone his executors, administrators, or assigns, or of this partner or partners, or of any of his clients or employers; And that in case the said Henry Campbell Small shall act contract to the last-mentioned covenant, or if the said Frederick William Kingstone his executors, administrators, or assigns, or his partner or partners, shall sustain or suffer any loss or damage by the misbehaviour, neglect, or improper conduct of the said Henry Campbell Small the said Catherine Francis Small ~~his~~ her heirs, executors, or administrators, shall indemnify the said Frederick William Kingstone and make good and reimburse him the amount or value thereof: and further that the said Henry Campbell Small will at all times keep the secrets of the said Frederick William Kingstone and his partner or partners, and will at all times during said term readily and cheerfully obey and execute his or their lawful and reasonable commands, and shall not depart or absent himself from the service or employ of the said Frederick William Kingstone at any time during the term without his consent first obtained, and shall from time to time, and at all times during the term, conduct himself with all due diligence, honesty, and propriety:

And the said Henry Campbell Small  
Doth hereby covenant with the said Frederick William Kingstone his executors, administrators, and assigns, that he, the said Henry Campbell Small will truly, honestly, and diligently serve the

said Frederick William Kingstone at all time during the said. Term, as a faithful clerk ought to do, in all times whatsoever, in the manner above specified.

In consideration whereof and of one dollar paid by the said Henry C. Small (the receipt whereof the said Frederick William Kingstone doth hereby acknowledge) the said Frederick William Kingstone for himself, his heirs, executors, and administrators, doth hereby covenant with the said Catherine Francis Small that the said Frederick William Kingstone will accept and take the said Henry Campbell Small as his clerk;

And also that the said Frederick William Kingstone will by the best way s and means he may or can, and to the utmost of his skill or knowledge, teach and instruct, or cause to be taught and instructed, the said Henry Campbell Small in the said practice or profession of a solicitor of the Supreme Court, which the said Frederick William Kingstone, now doth, or shall at any time hereafter during the said term or practise: And also will, at the expiration of the said term use his bet means and endeavors at the request, costs, and charges of the said Catherine Francis Small and Henry Campbell Small or either of them, to cause and procure him the said Henry Campbell Small to be admitted as a solicitor of the Supreme Court, provided the said Henry Campbell Small shall have well, faithfully, and diligently served his said intended clerkship; In witness whereof the parties to these presents have hereunto set their hands and seals, the day and year first above mentioned.
