Estate of Timothy O'Brien Send Letter Order to John Ryan Argentine

In the matter of Timothy O'Brien Deceased, know all men by these presents, that we, Mary O'Brien and
John Ryan [definition of some kind that I cannot read the handwriting], within the
state of Michigan are holden and stand firmly bound and obliged unto Esq. Judge of Probate in
and for said county of Genesee in the full sum of fifteen hundred dollars lawful money of the United
States of America to be paid unto the said Geo. R. Gold, his successors in the said office, or assigns, to
the true payment thereof we do bind ourselves, and each of us, our and each of our heirs, executors and
administrators, jointly and severally for the whole, and in the whole, firmly by these presents. Sealed
with our seals: Dated the 25th day of Sept Anno Domini one thousand eight hundred and seventy one.
Whereas the above bounden Mary O'Brien has been appointed by the Probate Court of said county,
administrative of the estate of Timothy O'Brien, late of said county [left blank] deceased:
NOW THE CONDITION OF THIS PRESENT OBLIGATION IS SUCH, that if the above bounden
Mary O'Brien shall well and truly perform, observe and keep the conditions following, to wit:
1st. That she shall make and return to the Probate Court aforesaid, within three months, a true
and perfect inventory of all the goods, chattels, rights, credits and estate of the said deceased, which
shall come to her possssion or knowledge, or the possession of any other person for her
2d. That she shall administer according to law, [left blank] all the goods, chattels, rights,
credits and estate of the said deceased, which shall, at all time, come to her possession, or to the
possession of any othr person for her and out of the same pay and discharge all debts [left blank]
and charges chargeable on the same, or such dividends thereon as shall be ordered and decreed by the
Probate Court aforesaid
3d. That she shall render a true and just account of her administration to the Probate Court
aforesaid, within one year, and at any other time when required by such Court: And [left blank]
4 th . That she shall perform all orders and decrees of the Probate Court aforesaid, by the
aforesaid Mary O'Brien to be performed in the premises: Then the afore written obligation to be void
and of none effect, or else to abide and remain in full force and virtue.

On Tuesday night or Wednesday morning last, a deserted railroad shanty standing a few rods north of the river at Richmond, and a few feet from the track, was burned. No alarm was made. In the morning the body of a man was found among the ashes, surrounded by hard-wood coals, ashes, and partly burned sticks. The legs were burned off to the body, the arms were burned off above the elbow, the skull and the breastbone were bare and so burned as to crumble at a touch. The remains were on the windward side of the light pine shanty, so that the flames would be blown away from the body, therefore it appears that fuel must have been piled on the body and kept burning a long time before the shanty was fired. Near the body were found pieces apparently belonging to a watch chain. No traces of a watch could be found. Dr. H.H. Stimson made the postmortem examination, but could not find the cause of death owing to the badly burned state of the remains. A blade from a pocket knife, found near the body, has been identified as belonging to one O'Brien, keeper of a railroad boarding house near Fenn's Mill. O'Brien had been to Holland to collect money, and, it is supposed, was walking along the track on his way home when he was killed, plundered and an attempt was made to hide the crime by burning the body. Several men have been arrested and their examination is going on as we go to press.

Detroit Free Press (Tuesday) March 7, 1871 pg 4

Murder in Allegan County.

The Kalamazoo *Telegraph* has the following account of an atrocious murder which was committed near Richmond, in Allegan County, last Tuesday night:

A man who has been for some time past engaged as a laborer on the Chicago & Michigan Lake Shore Railroad, and who also kept at Sherman's Mills (a point on the above named railroad, in Clyde Township, Allegan County, eight miles north of the junction of the railroad with the Kalamazoo & South Haven Railroad) a boarding-house for the gang of men employed on that section, by the name of O'Brien, is doubtless the person who was killed.

It seems that the contractors, whose headquarters for the present are at Holland, owed O'Brien some \$200 for labor and board of men, and O'Brien had gone to draw his pay. The money was paid to him, and he was on his way home on foot through the woods when he arrived at night-fall at Richmond, a little village about ten miles this side of the mouth of the Kalamazoo River, and a station on the Chicago & Lake Michigan Railroad. Here he determined to stay until next morning, and to this end he ordered supper and lodging. Just as he was about to retire for the night, two men, strangers in the place, called at the tavern where O'Brien was and asked to see him. With these two men O'Brien

subsequently went out, and that is the last that is known about him. The next morning an old shanty near Richmond was seen to be smoking and almost burned up. Looking closer the remains of a human being were discovered in the midst of the heap of smouldering [SIC] embers, but so charred, dismembered and disfigured as scarcely to be recognized for what they really were. The news soon spread through the little village, and means were at once taken to rescue the body from its fiery bed. A messenger was sent to a deputy sheriff, and subsequently two men by the name of Hogle and Hayward (one formerly a boarder of O'Brien's) were arrested on suspicion of being concerned in the burning of the body.

The arms and legs of the unfortunate man were burned off, his features destroyed, and nothing left of him that could lead to his recognition. Under one of his arms a little bit of his shirt was found, and near by a piece of a woolen comforter that had belonged to him, also his knife. The remains were taken to Sherman's mills, where his family are, and the knife and woolen comforter were recognized; the knife by a peculiar break in the point of the blade which had often been noticed by members of his family.

It is not known how the murdered man came to his death—whether he was beguiled to a lonely spot
and dispatched with few or many blows, and then the body conveyed to
vel we have spoken of; or whether heered therein, and the fire lighted inall traces of the

MICHIGAN NEWS

3-8-1871 Detroit Free Press, pg 1, reported by Mr. Nathan Hill, Clyde Twp

ALLEGAN COUNTY

The Kalamazoo *Telegraph* of the 6th says:

We learn from Mr. Nathan Hill, of whom we gathered the particulars of the O'Brien murder, published Saturday, that another homicide had been discovered there. Last Friday morning an unknown man was found lying upon the snow, three miles north of Richmond, his right leg cut almost off. The body was brought to Richmond on Friday morning.

The same authority says that Hogan and Hayward, suspected of the murder of O'Brien, had an examination before the Justice of the Peace in Clyde Township, and were held to bail, but not being able to give bonds were committed to jail to await trial.

Article #5

Detroit Advertiser and Tribune Mar 9, 1871 Murder in Allegan County. A Man Murdered for His Money and His Body Burned. Correspondence of The Detroit Tribune. Kalamazoo, March 8, 1871.

We learn that a most atrocious murder was committed at Richmond, Allegan county, about 10 miles this side of the mouth of the Kalamazoo river, a point on the Chicago & Lake Michigan Railroad, last Tuesday night. As near as I can learn, the circumstances are as follows: A man named O'Brien, a laborer on the above named Railroad, and who also kept a boarding house at Sherman's mill, for the gang of men who work on that section of the road, started last week to go to Holland to get his pay, some \$200 in money. He had succoeded [SIC] in his mission and returned as far as Richmond, Tuesday evening, where he intended to remain over night and go on the next day to Sherman's mill, which is in Clyde township, some eight miles north of the junction of the Kalamazoo and South Haven Railroad with the above named road. With this purpose, he stopped at a tavern in Richmond, but after he had been there some time, two men came to the tavern and requested to see him. He was called, and finally went out with them and was seen no more. At four o'clock in the morning, an old shanty not far distant from the tavern was discovered to have been fired and was nearly burned up. On investigation the remains of a human being was found in the smouldering [SIC] ruins, the body terribly charred, both

legs and arms burned away, and nothing left of his form or features for identification. Under one arm pit a piece of a shirt was found that had escaped the fire. A knife and a portion of a woolen comforter were also found. Subsequently, these were identified by the wife of O'Brien. The knife, especially, was known to be his by the wife and son, who recognized a peculiar break in the point of it, which they had both frequently noticed. A deputy sheriff brought the remains of poor O'Brien to Sherman's mill, Thursday. It is supposed that two men named Hogle and Hayward were the perpetrators of the act, and they have both been arrested on suspicion. O'Brien was an honest, hard working man of good habits. He leaves a wife and three children, utterly destitute of means and application has been made to the township of Clyde for aid for them.

It is supposed that O'Brien was murdered and then conveyed to the shanty, and that was fired to conceal the evidences of guilt. As yet, however, no trace of blood has been discovered, and the body is so badly mutilated by fire as to conceal all blows, if there were any inflicted.

Atrocious Murder

On Tuesday, the 2d inst., one O'Brien, an employee and boarding-house keeper of the C. & M. Lake Shore R. R., at Sherman's mill, 10 miles south of the mouth of the Kalamazoo river, returned from Holland with \$200 in his possession and stopped at a tavern in Richmond for the night. During the evening he was called out by two men, and never seen again. Before daylight an old shanty, not far distant, was burned, and in the ruins were found the remains of a human being past identification, but with a knife and two remnants of clothing were positively identified by O'Brien's wife as belonging to him. Two men, named Hogle and Hayward, have been arrested on suspicion.

- -- Two more murders have been committed at Richmond, Allegan county, Mich., the scene of the horrible murder which occurred there recently. On Thursday night an unknown man was killed by unknown parties, and on Friday night the body of another unknown man, apparently a laborer, was found in the road three miles north of the settlement, a fearful gash in the thigh severing the arteries. There is no clue to his murderers. The town is whisky-cursed, [SIC] which is probably the source of those and other horrors.

Obtained from the marriage register of this church May 17, 2013.

More: Unable to discover a Margaret Ryan so far, as related to John Ryan of Deerfield, Livingston Co.

More: If their birth years are/were correct on the 1860 census, this marriage would have taken place when they were each 14-15 yrs old. If the 1850 census is correct, Tim would have married at about 27 yrs of age, and Margaret at about 20.

"In the matter of expenses incurred, in and about the inquest upon and burial of the body of Timothy O'Brian [SIC] a stranger not belonging to the State of Michigan. On this matter it appearing to the court now here that the body of the said Timothy O Brian was on the 1st day of March AD 1871 found

lying dead in the township of Manlius in said county, and it further appearing that an inquest was taken upon the body of said Timothy O'Brian before Gustarus Myers Esq. a Justice of the Peace in and for said Township of Manlius on the 1st, 2nd, 3rd, and 4th days of March AD 1871. And it further appearing to the court by the certificate of the said Gustavus Myers, Esq. as such Justice of the Peace that said Timothy O'Brien [SIC] was, at the time he was found lying dead as aforesaid, a stranger not belonging to this State, and that said Justice of the Peace caused the body of said Timothy O'Brien to be decently burried [SIC] and it further appearing by the Certificate of said Justice of the Peace and by the vouchers accompanying the same that the fees of the said Justice of the Peace, expenses of said inquisition, and of the burial of the said Timothy O'Brian [SIC] amount to the sum of \$149.53. Whereupon it is ordered that the said sum of \$149.53 be and the same hereby is allowed in pursuance of § 6099 of the Compiled Laws. Charles R. Brown [Circuit Judge]"
