5-24-95 Mrs C. Ebmeyer has rented the Ebmeyer building on Water street and is prepared to fill orders for baking of all kinds.

9-18-96 John Hirner has purchased the Ebmeyer building on Water street. He will greatly improve the premises and building, which will be occupied by August Pfaff, Jr.

FRANCIS BUILDING

3-5-80 John Francis has bought the old Engine House [\$50.00] building and is fitting it up for a meat market -(Butler Street)

4-16-80 Johnnie Francis has moved into his new market next to A B. Taylors Store. He has one of the nicest markets in town. (did not move old engine house building which is just south of the Odd Fellows Hall, just put shop into it.)

10-12-83 Meat Market Notes. -- The caterers of the public in the line of roasts and steaks have again changed bases of operation . The Messrs Walz Brothers have leased the shop of John Francis for a term of years , and are at present there serving their customers with the best the market affords

10-19-94 The Francis market building is being moved to a location a little south of where it formerly stood .

10-25-95 James Davis and F. VanHusen have opened a meat market in the Francis building

4-12-97 P. A Wolfe, of Howard City, graduate of the Philadelphia optical college, has rented the Francis building , and will put in a stock of jewelry about May 1st . He is an experienced jeweler and will operate in the jewelry and optical business together .

7-22-98 Last Thursday night , about midnight , fire broke out in the Francis building next the bank block , resulting in the total destruction of that building and a narrow escape of the adjoining buildings. The fire was first discovered by Russel Taylor, who gave the alarm. Those first on the scene discovered the interior of the building to be full of flames , indicating that the fire originated on the inside. The fire engine was quickly manned and a stream of water on the building , together with the efficient work of a bucket brigade , was effective in saving the bank block , although it is doubtful if this would have been accomplished but for the timely arrival of the Douglas fire engine with a good crew of workers. The burned building was occupied by P. A Wolfe, jeweler and optician, who had an insurance on stock and fixtures of \$650. Dr. G. H. Perrin , dentist , occupied the front rooms in the bank block , and suffered a loss of about \$125 on his office fixtures , which is fully covered by insurance . Russel

Taylor occupied the rear rooms, and the damage to his furniture and personal effects was in excess of \$100, with no insurance . The damage to the bank block has not been estimated , but it is not serious and is covered by insurance.

Gerber, went to Ferrysburg yesterday and contracted for brick to build a two story building 48 x 60 feet in size , double store , which he will erect on the southeast corner of the Dickey lot in Douglas . One of the stores will be occupied by Corneil Gerber as a hardware store . The other will be rented .

5-30-90 Frank Seastrum has secured the job of doing the mason work on the new Gerber Block, in Douglas

6-6-90 A scow load of brick for the new Gerber block in Douglas arrived from Ferrysburg last Sunday. This building will be first class in all respects , galvanized iron cornice , cement cappings, etc. Evert Takken will do the carpentry work.

8-29-90 McDonald & Beebe will soon occupy their new quarters , in the Gerber Block , with a bran new stock of goods .

4-15-92 McDonald & Bebee are making ready to occupy the west half of the Gerber block on the 15th of the present month . They will fill the new store with a fresh stock of dry goods and clothing and occupy their present quarters exclusively with groceries and boots and shoes.

4-10-96 The Douglas hive, K.O.T.M. will give a 'New England' supper Saturday evening, April 11. Price of supper , 15c . A carpet will also be sold to the highest bidder . All are invited to attend. At Gerber Hall.

10-15-96 There will be various changes of business locations in Douglas shortly and it will be necessary to get out a business directory of the town to enable people there to know where to do their trading. Plummer & McDonald have purchased the Gerber block , paying therefor the sum of \$3000. H. A. McDonald will occupy the building vacated by the above firm .

10-13-99 R. M. Gillett completed putting a foundation under his residence and moved his family into it from the McDonald building the fore part of the week .

GOSHORN BUILDING/ GOSHORN BLOCK - N end lot 107 108 ? Lot 73 -Kzoo Plat

Brandstetter is refitting the building formerly occupied by F. A. Winslow and will move his jewelry store in it tomorrow. (Goshorn Block)

2-7-79 Our popular jeweler, J. Brandstetter is settled in his neat store in the Goshorn Block

5-16-79 Miss Lina(Selena) Chadbourne has opened a new stock of millenery at her old stand in the Goshorn Building

8-15-79 C.H. Hunt has purchased the building formerly occupied by J. Brandstetter as a jewelry store . (Goshorn Building) will occupy the building as a shoe store and residence.

8-22-79 C. H.Hunt has removed his shoe store from the Roche building to the Goshorn Building.

- 3-5-80 A H. Gardner is fitting up the room formerly occupied by Miss Selena Chadbourne in her millinery business, preparatory to Mrs Gardner putting in a stock of fancy and millinery goods. A skylight is among the improvements and it will add greatly to the pleasant appearance of the rooms.
- 4-9-80 W. A Woodworth has bought the John Goshorn building facing on the Public Square . He will fit the upright for a Law Office and will occupy the wing as a residence
- 4-15-81 Mrs Gardner has moved her millinery goods into the rooms recently occupied by C. H. Hunt
