### SAUGATUCK 75 YEARS AGO

In 1915 our family of Oak Park, Illinois, took one of the Graham & Morton ships to Macatawa and traveled to Saugatuck by Interurban Railway. My father asked about a hotel, which turned out to be no longer available, and a man offered the services of his hotel, Park House, within walking distance of the station. Our family stayed there regularly until 1925.

Hal Redmon was later one of my competitors, idols, once my shipmate on a boat in the Mackinac Race. About 1924 I spent the summer at Wayne Weed's farm. In all I made 27 visits to Saugatuck by sailing yacht and made my last visit to the area in 1988.
