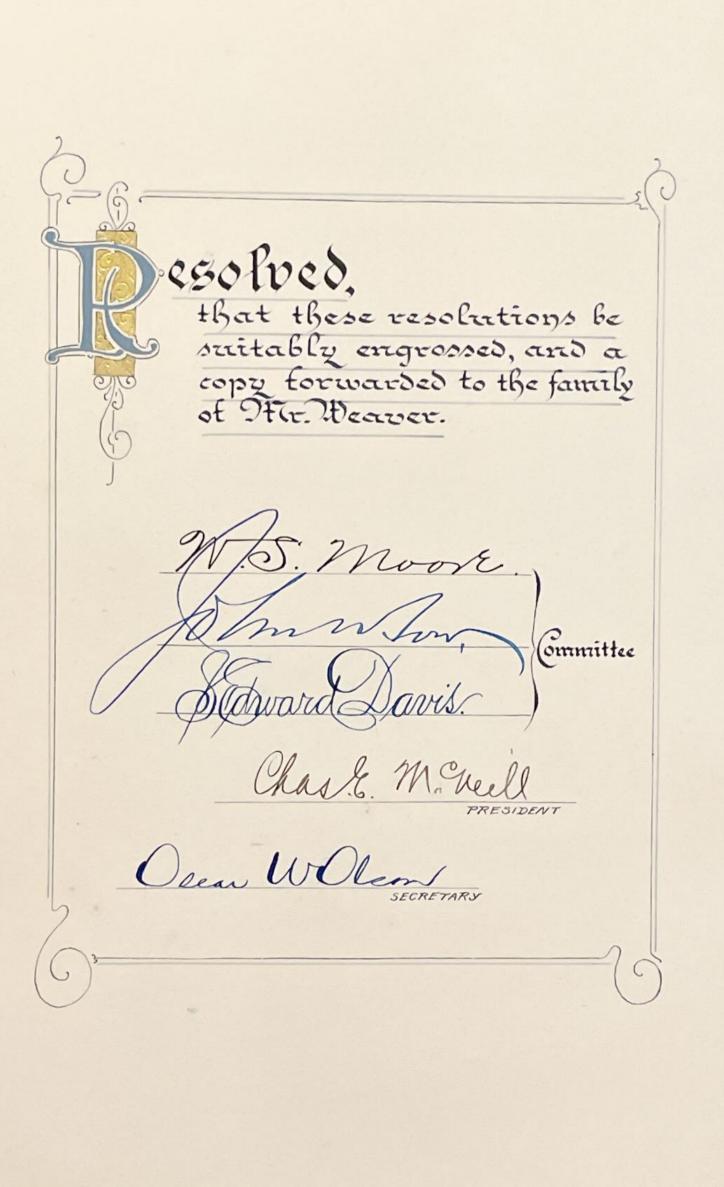

LAST HONORS TO MR. WEAVER.

Funeral Largely Attended by Trade— Floral Offerings Beautiful.

Chicago Dec. 12.—Charles H. Weaver, the veteran commission man, who passed away last week after a short illness, was buried at 2 p. m. Saturday from his late residence, 2943 Washington Boulevard. The funeral services were conducted by Rev. C. Polson, pastor of the Universalist Church, and interment was at Rosehill Cemetery.

There can be no more fitting and conclusive indication of the esteem in which Mr. Weaver was held than the fact that despite the storminess of the day the attendance was the largest recorded in the history of the trade for a similar occasion. The floral offerings were plentiful and beautiful and represented a sentiment from practically every association and business institution of the trade. South Water St. and kindred businesses in other sections of the city were abundantly represented, and those in special prominence among the attendants were the old timers of the trade, who ad pioneered with and long known Mr. Weaver.

The pallbearers were William L. Wagner, of G. M. H. Wagner & Sons, ex-president of the Western Fruit Jobbers' Ass'n and the International Apple Shippers' Ass'n; L. B. Kilbourne and F. W. Moff, both of whom have long been associated with Mr. Weaver in the business; John W. Low. of Wayne & Low, ex-president of the Exchange and president of the Chicago Cold Storage Warehouse Co.; Wm. J. Ellis, of W. J. Ellis & Co., and S. Edward Davis, executive secretary of the Chicago Mercantile Exchange.

Every member and employee of Weaver & Co., as well as many exemployees, were present to pay their last respects. Among those who attended were L. A. Goss, manager of the Minneapolis Cold Storage; Chas. E. McNeill, president of the Chicago Mercantile Exchange; Joseph T. Milnarick, vice-president of the Exchange, and John C. Scales, ex-president of the National League.

DEATH OF AN OLD PIONEER.

Hiram H. Marsh Died Last Monday Evening, Aged 75.

Hiram Hosmer Marsh, the pioneer settler of Monte Vista, died at his residence Monday, January 22, at 9 o'clock p. m., of neuralgia of the heart and his funeral was attended from the residence at 2 p. m. today and his remains now rest in the Monte Vista cemetery.

Mr. Marsh was born in New Hampshire in 1824, and early in life moved to southern Illinois where for several years he was engaged in fruit raising and afterwards went to Chicago to engage in the commission business. He came to the San Luis valley in 1881 for his health and was one of the pioneers in the building of the Lariat ditch and conducted early and exhaustive experiments, showing what could be done in the way of fruit, grain and vegetable raising on the mesa lands of the valley which previous to his coming here were not considered worth 25 cents an acre.

Mr. Marsh was liberal to all enterprises which commended themselves to his judgment and he contributed over \$3,000 to the building of the Soldiers Home. He was a cousin and playmate and an intimate friend of Harriet Hosmer, the noted sculptress, and was himself of a strongly literary and scientific term of mind. He leaves here a property probably worth

the result of a lifetime of careful and intelligent industry, which Mr. Charles Weaver of Chicago, a nephew of Mrs. Marsh, is here to look after.

Mr. Weaver was a far-sighted business man. Years ago he started to surround himself with able men to carry along the business of C. H. Weaver & Co., and has built up an organization that is recognized as the peer of any in the country in this line of industry. So well is the organiza-tion managed that his personal presence was unnecessary in carrying along the business, although he always has supervised its operation and together with his colleagues made plans for the future. C. Arthur Weaver, his son; F. William Morf and L. B. Kilbourne, all of whom have been associated with the firm as department managers for more than 20 years, and who shared with Mr. Weaver the responsibility of the business, will continue the firm under an unchanged policy.

Mr. Weaver became ill early in November but apparently was recovering nicely when a cold developed which later turned to pneumonia. He is survived by his widow, Carrie Ed-monds Weaver, and their son, C. Arthur Weaver. Burial will take place in Rose Hill cemetery.

\$860,000 Estate Left by Charles H. Weaver

An estate valued at \$860,000 was left by Charles H. Weaver, late head of the commission firm of C. H. Weaver & Co., at 67 West South Water street, according to a petition for letters of administration presented today to Raymond J. Darby, assistant to Probate Judge Henry Horner.

As Mr. Weaver left no will, the estate will be shared by his widow, Mrs. Carrie A. Weaver, and son, Charles Arthur Weaver, both of 2943 Washington boulevard.

Letters of administration were issued by Mr. Darby to the son at the request of his mother. The estate is said to consist of \$700,000 in personal property and \$160,000 in real estate. Mr. Weaver died Dec. 4

C. H. WEAVER, CHICAGO FRUIT AND PRODUCE MERCHANT, PASSES ON

Had Been for Years One of the Best Known Figures in the Trade-Built Up a Big Business from a Small Beginning-Always a Leader in Business Ethics.

Firm of C. H. Weaver & Co. Will Be Continued Along Same Lines By His Son, C. Arthur Weaver, F. William Morf and L. B. Kilbourne -Widow and Son Survive, Him.

Chicago, Dec. 5.-Yesterday morning at 11 o'clock that Hand which guides the destiny of all saw fit to bring to a close the life of one who was dearly beloved of all, C. H. Weaver, of Chicago.

Mr. Weaver was one of the best and most favorably known figures in the fruit and produce industry. He was born in Utica, N. Y., 76 years ago. He came to Illinois with his parents when four years old and in 1862 came to Chicago and founded following year the business which bears his name, and which is now in its 57th year, C. H. Weaver & Co.
