6 they after amended or adopted. This certificate can be transferred
7 only in the manner prescribed ARTICLE I. BY-LAWS.

9 SECTION I. There shall be three classes of members:
10 one, regular active members; two, single associate members; and
11 three, family associate members.

12 SECTION II. Regular Active Members. Any person of
13 good moral character of the age of 21 years or over, may become a
14 regular active member upon application made to and approved by
15 the Board of Directors, in the manner hereinafter provided. Active
16 membership in the club shall be limited to one hundred
17 (100) members.

18 SECTION III. Single associate members shall be en-
19 titled to the same privileges in the use of the club house and
20 grounds and be subject to the same requirements as regular active
21 members for themselves individually, but shall not be entitled to
22 vote at any meeting or hold any official position in the club.

23 SECTION IV. Family associate members shall be entitled
24 to the same privileges in the use of the club house and grounds
25 for themselves and their families and be subject to the same
26 requirements as regular active members, but shall not be entitled
27 to vote at any meeting or hold any official position in the club.
28 No certificate of membership shall be issued to either class of
29 associate members.

30 SECTION V. Any person who may desire to become a mem-
31 ber of the club shall present or cause to be presented to the
32 Board of Directors an application signed by himself and two mem-
33 bers of the club, in good standing, as sponsors for him. As soon
34 as said application shall have been received, it shall be referred
35 to the Board of Directors, who shall look into the desirability
36 of the applicant as a member, and if satisfied of his fitness,
37 shall approve of his membership at next regular meeting by at
38 least a majority vote of said board members, provided membership
39 in the club is not filled. If membership is filled, then said
40 applicant will be acted upon in the order in which his application
41 is received. Upon payment of membership fees, such applicants as
42 passed upon shall immediately become a member.

43 SECTION VI. Membership Certificate. There shall be
44 issued over the signatures of the President and Secretary of the
45 club, with the corporate seal impressed thereon, to each active
46 member of the club, who is fully paid up, a certificate of mem-
47 bership, substantially in the following form:
