Spiritual Benefits Derived by All Members of the Auxiliary

Mass, Holy Communion, and Beads are offered once a month by each sister in the community for all Benefactors, living and dead.

When a Benefactor of the Community has departed this life, each sister offers Mass and Holy Communion for the repose of his or her soul.

During the Octave of All Souls, a Requiem Mass is sung for deceased Benefactors.

A petition for the eternal welfare of all Benefactors is made twice daily by the assembled Community.

Besides, each sister is under the obligation of frequently recommending to God in prayer the souls of Friends and Benefactors, living and dead.



By-laws

Article I.

Name

The name of this organization shall be LORETTO WOOD-LAWN AUXILIARY.

Article II.

Object

This society was organized in January, 1927, for the purpose of promoting the interest of Loretto Academy, Woodlawn.

Article III.

Officers

Section 1. The officers of this society shall be Honorary President, President, Vice President, Recording Secretary, Corresponding Secretary, and Treasurer.

Article IV.

Duties of Officers

Section 1. The Honorary President shall be the Mother Superior of the Ladies of Loretto, Woodlawn Convent, and the business of the society shall be conducted subject to her approval.

Section 2. The President shall preside at all meetings, and shall, shortly after election, appoint Chairmen of Committees.



Section 3. In the absence of the President, the Vice President shall preside.

Section 4. The Recording Secretary shall keep the minutes of the meetings and read them at the following meeting.

Section 5. The Corresponding Secretary shall conduct the correspondence of the society, issue all notices, have charge of the stationery, and send out notices of dues.

Section 6. The Treasurer shall collect dues and pay any necessary bills by order of the Executive Board.

Section 7. The Executive Board shall consist of Officers, Chairmen of Committees, Retiring President, and two Directors elected by vote.

Article V.

Membership

Section 1. Mothers, guardians, and friends of the Academy students, the Alumnae, and all interested in the Ladies of Loretto are eligible for membership.

Section 2. All members active during the year 1927 are charter members.

Section 3. Names and addresses of applicants for membership shall be presented in writing to the Membership Committee.



Election to membership shall be by vote of the Executive Board, and application properly approved shall be presented to the Corresponding Secretary.

Section 4. Membership shall be terminated by formal resignation or for non-payment of dues.

Article VI.

Dues

Section 1. The club year shall be same as the calendar year. Annual dues shall be \$2.00, payable in advance.

Section 2. Members in arrears shall be notified by the Corresponding Secretary one month after dues are payable.

Article VII.

Committees

Section 1. Social Committee. This Committee shall consist of a Chairman and as many members as the Chairman sees fit to select. The duty of this Committee shall be to attend to the social side of the meetings of the Auxiliary.

Section 2. Membership Committee shall consist of a Chairman and five to ten members. Their duties shall be to increase the membership.

Section 3. Press Committee shall consist of a Chairman and two members, and shall have charge of the Year Book, the printing of tickets, and all matter given to the press.



Article VIII.

Meetings

Section 1. Meetings of the society shall be held at the Woodlawn Convent, the first Monday of each month from October to May, inclusive.

Section 2. There shall be no donations solicited nor moneys collected at any of the meetings except for the benefit of this society.

Section 3. By-laws may be amended at any meeting by a vote of the majority.

Section 4. Five members shall constitute a quorum.

Article IX.

Elections

Section 1. At the regular meeting in April of each year, a board of three election commissioners, none of whom shall be a member of the Executive Board, shall be nominated from the floor and elected by a standing vote of the Auxiliary.

This Committee shall report candidates at the regular May meeting.

Section 2. Election of officers shall take place at the May meeting. At that meeting there may be nominations from the floor. Should there be more than one candidate nominated for office, the election shall be by ballot. If there is but one candidate for office, election shall be by voice.
