It was voted that 2/3 of mem number present at meeting wold be memeratery necessary to reject an applicant for membership. Voted to have 1 vice commander, voted that Executive Com. consist of the regular officers & 4 additional members, voted to give each member 7 days notice before amending the constitution, voted that on petition of 3 members of this post, Commander must call a meeting of Executive Com., voted that 5 members shall constitute a quorum of Ex. Com., voted that the regular meeting date of this post be the first Tuesday of every month, voted that upon written request of 7 members the Commander must call a special meeting of this post, voted that 7 members at any meeting of this post shall constitute a quorum to do business, voted that a notice be posted 7 days prior to amending the by-laws of this post, voted that a member of this post hold more than one office, voted that vacances in office shall be filled by vote of this post voted to adapt by-laws & Constitution as set up.
