SUBJECT: GENERAL OPERATING INSTRUCTIONS REVISION 1987

General Operating Instructions
Revision 1987
is effective at 0001 Sunday, November 29th
superseding those of June 1st, 1985.

Employees whose duties are in any way affected by the time table must have a copy of General Operating Instructions accessible while on duty.

Some significant changes are:

- * With the exception of Rule 14(m)(1), Rule 285A and Rule 290, all references to operating rules have been removed from Section 1.0 of time table System Special Instructions and placed in Section 2.0 of General Operating Instructions.
- * Engine and Train Handling Instructions, Form 697 dated May 1977, is cancelled in its entirety and replaced by the instructions contained in Section 16.0 of General Operating Instructions.
- * Canadian National Railways Air Brake Minimum Inspection Testing and Operating Standards, Form 8915 B dated March 1, 1986, is cancelled in its entirety and replaced by the instructions contained in Section 17.0 of General Operating Instructions.
- * Special instructions relating to Canadian and United States Hours of Service are contained in Section 18.0.
- * Federal Administration (FRA) Regulations, control of alcohol and drug use are contained in section 19.0.
- * Section 20.0, Fire Extinguishers, has been deleted and will be carried in a future issue of Safety Rules.
- * Section 21.0, First Aid, has been deleted and will be carried in a booklet issued to those who receive First Aid training.
