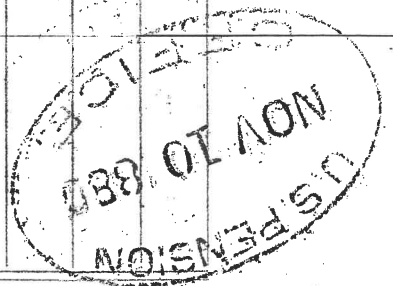


1 With what disease he became affected, but

 12 the hardships of the service up to the time
 13 of his capture as well as the average
 14 soldier. That at the time he was cap-
 15 tured he was sound and ably bodied
 16 and as affiant believes from from any
 17 disease particularly of the disease and
 18 kidneys. That said Croase was a good
 19 soldier and always performed the duty
 20 assigned him faithfully and well. The fact
 21 above state are all within the personal
 22 knowledge of affiant - he has no interest
 23 in the claim of said Croase for a
 24 pension or increase in his pension.
