of-town guests use the club house and swimming pool.

Out-of-town guests are defined as persons residing outside of Mobile or Baldwin Counties, Alabama, but shall not include summer residents of Baldwin County, nor persons temporarily residing in either of the above named Counties.

Full Members and Business Members shall be entitled to have guests who are residents of Mobile or Baldwin Counties use the facilities of the golf course, club house and swimming pool, but the same resident of Mobile or Baldwin Counties shall not be eligible for such privileges more than twice during each calendar month.

House Members shall be entitled to have guests who are residents of Mobile or Baldwin Counties use the facilities of the club house and swimming pool, but not of the golf course; but the same resident of Mobile or Baldwin Counties shall not be eligible for such privileges more than twice during each calendar month.

Swimming Members shall be entitled to have guests as defined above, under the same terms and conditions, except their guests shall have the privileges of the swimming pool only.

A member who owns a lot in Lakewood Club Estates shall be entitled to exercise those rights as to guests that are set forth herein and that are applicable to the particular class of membership to which such member belongs, provided however that out-of-town guests of such a member, in such member's home in Lakewood Club Estates, shall not lose their out-of-town status, by virtue of temporarily residing in such home, either as a guest or tenant of the owner.

All such guests shall pay green fees and swimming pool fees in accordance with rates established by the Management or the Membership Committee. There shall be no charge for use of the club house only.

All guests using the golf course, club house or

swimming pool must be accompanied by the member or qualified member of his immediate family, or present written authorization from the member.

Any member who requests the extension of guest privileges shall be responsible for any charges incurred by such guests.

The privileges of the golf course, club house and swimming pool shall be extended to any guests of the Grand Hotel upon payment of green fees in accordance with rates established by the Management or the Membership Committee. There shall be no charge for such guests to use the club house or swimming pool.

The Membership Committee shall have full control over the extension of guest privileges and shall have the right to refuse or revoke guest privileges at any time.

TEN CHANGE IN STATUS OF JUNIOR INDIVIDUAL MEMBERS

If any person holds a Junior Individual Membership, he shall, upon attainment of the age of 35 years, pay the additional initiation fees provided for below in order to move into the Individual Membership as follows, viz.:

(1) If he has been a Junior Member for 5 years — \$416.67 plus tax.

(2) If he has been a Junior Member for less than 5 years — \$833.33 plus tax. provided however, that this paragraph shall not apply to:

(i) sons or sons-in-law who are exempted under paragraphs 3 and 5 hereof from paying any

initiation fees; or

(ii) persons who now are, or at the time of application for membership were, sons or sons-in-law of individual members, and who have already paid the Junior Individual Membership Initiation fee of \$416.66.
