

# LOYALISTS RUSHING TROOPS TO SOUTHEAST

## GIJON VICTORY STRENGTHENS REBEL FORCES

Insurgent Troops In the North To Be Released For Other Fronts

HENDAYE, France, Oct. 23. (UPI)—The French government reported rushing reinforcements to the Teruel and Aragon fronts today to strengthen insurgents who are planning an attack on Valencia, in Spain.

The insurgents are moving up in northern Spain, following the surrender of Gijon, where they released most of the 30,000 troops there for service in other fronts.

Loyalists estimated the drive through Asturias cost the fascists 30,000 men.

Premier Juan Negrín of the Va-

lesquez government, capitulating to pressure from European democracies permitted Italian and German planes to drop arms which the insurgents were using in the northwest.

Government militiamen were strag-

gling into Gijon and surrendering,

and large quantities of mun-

itions and armaments had been

seized in Asturias.

Officials Reach France

PARIS, Oct. 23. (UPI)—Planes from four Spanish cities in their province, three former Asturias districts, reached France today about 10 a.m.

Leon Bolívar Tomas, former provincial governor, and most of his cabinet arrived at Durango, and a naval landing workshop in the Bay of Biscay.

Two of the former cabinet mem-

bers, Ramón Alvarado and Federico García, telephoned to the Associated Press office here and de-

cided to remain in Spain.

Spain refused to accept an Italian proposal for withdrawal
