- Correct both copies of the computer print-out membership list in the following 1. manner:
 - a) ALPHABETICALLY TYPE or BLOCK PRINT any changes, corrections, new members, reinstated members and FFGC Life Members. Be sure ADDRESSES ARE COMPLETE and include CLUB CODE. See current Book of Information. The corrections can be made on the print-out or use Forms C-1/C-2/D-3, Member Information/Dues Transmittal. Separate members by Circles if on Circle plan.
 - b) Mark deletions with a "D".
 - c) Mark change/correction in name or address with a "C".
 - d) Mark new members with an "N".
 - e) Mark reinstated members with an "R".
 - f) Mark FFGC Life Members with "LM". Report all deletions with reason and include LM number. An LM may be dropped from the club, but cannot be dropped from FFGC Life Membership file unless deceased.
 - g) New members, changes or deletions received after March 30th, are not included in listing as computer lists are processed six weeks before mailing.
- Sometimes members belong to more than one club, and are entitled to an issue for 2. each club in which they are listed. Check with these members with regards to their receiving more than one copy of THE FLORIDA GARDENER.
