Good Afternoon Donna,

Hope all is well and good with you and your family. We held our Oct. Board Meeting this past Monday. Garden Walk conversation's did come up, however, once we finish this District Meeting on Monday, Oct. 21, we will move on GW full steam ahead.

Dee Dee and I would like to meet with you one day after Oct. 28. I am free On Wed. Oct. 30, at 11:30 am. I have all day on Thursday, Oct. 31, open, and if we have to move into Nov. the 6th would be open all day, too. You and Dee Dee please let me know if any of these dates work for you and we will confirm a time.

Donna, I suggest that **you send out an e-mail or even make a personal call to each person on the Garden Walk Team.** It's time to confirm that everyone on the team is on board. You never know when somebody has decided to drop off. The team is super important to keep the Garden Walk 2014 running like that well oiled machine we spoke about. It's also **necessary for you to have a Co-Chair** to work with and have your back. Of course, Dee Dee and I are around, however, you need a person you enjoy working with to assist with all the paper work, phone calls etc. DON'T wait for someone to volunteer ~ Call them, go to their house personally or whatever it takes.

Remember, **once you preview a property, there is a request letter** noting your intent to have them on the walk. Be wise and use your team as your back door - by saying - my team has to approve before I can confirm. That gives you an out if there is an issue, like a better property, or if the distance is too far from your other properties. Once you see that the property falls into place, and the owner has said they WILL be on the walk, **THEN, you must send a documented confirmation letter** (which they will need to respond to with their written confirmation) to prevent them from changing their mind, which would be a huge issue after ticket's go to print. We have never had anybody fold on us, but, that final confirmation in writing is of utmost important because of our ticket and map. Dee Dee and I found that e-mail was the quickest communication form and easy for the owner to communicate with you throughout the process. It also gives you a hard copy of details you have sent. This is where having a co-chair falls into place. PLUS, MORE THAN one person needs to be able to step into leadership if one of you has a problem or illness (god forbid). FYI I know you have sample letter's, but, Dee Dee can walk you through this process again if you need. I know you can RUN A town, so, I am just throwing out a little food for thought and then you take it and do your thing.

Touching base with **Jean Simmons head of your host and hostesses** for 2014 is a SUPER IMPORTANT person, also. A call to her after District would be a good idea.

**Team Meeting - November prior to Thanksgiving** is a smart time to have a team meeting. This gets everybody on the same page and let's you know if you have any weak areas.

Just a reminder, also, that a **commercial property** (which is part of our giving back to the community) will need to be previewed and on board after to see between what MM works with your GW properties. If you have one in mind it's good and smart to



get them on board early on. Commercial Properties sometimes need extra special care because they have their client's or business to shape the walk around. They can also need more hands on (hostesses) on the day of the walk depending on how big, how busy etc. You want the commercial property to be super happy with your organization of everything.

Another reminder, The letter that you send with all the dates needed to be on the property, **Feb. 5, 2014, is media day** and notices have to go out to all properties and request for photo's and use in local paper's etc. Lonell can help you with that day. **Preview Day ~ for all our volunteer's (working the day of the walk) is Wed. February 26, 2014.** This is a special day for all of your team and host and hostesses etc. Anyway, you just need to give your property owners a heads up "early on" about these dates, and then, as Dee Dee will tell you ..... you will have to remind them with an e-mail or a call. Plus, if there are gates, get the codes, or have Gardner's, landscaper's or property owners there on that day to let you in. You do not want to come with a big group of volunteers and be locked out of the property. Just another reminder.

All of these are just reminder's that will help you keep yourself calm and running smoothly. You need that Co-Chair. Dee Dee and I will be happy to help you coach him/her if you need us to.

As Lonell said, we have the TDC \$ this year and we really need to be organized and timely. A Co-Chair will ease your load. I did this one year by myself and that's the last time, ever! I recruited Dee Dee! It's a must!

I will have **Vicky order paper for our** G W ticket's before Christmas. We have had pink ticket's (different shades) the past two years. How do you feel about a lime green ticket paper color in 2014 with navy blue lettering? If you agree I will order.

The Garden Walk is the fundraiser that keeps our precious little club up and running. Your position is very important to the club, all the member's and especially to me and Dee Dee. Having you team on board, a co-chair and a meeting before Thanksgiving and all the Holiday season will help you feel at ease. I'm telling you the team is amazing. Let them know you are excited and happy and you will have them at your beckon call.

Let me know if any of the dates I listed above work for you for us to get together prior to a team meeting, or, send me and Dee Dee dates that are good for you.
