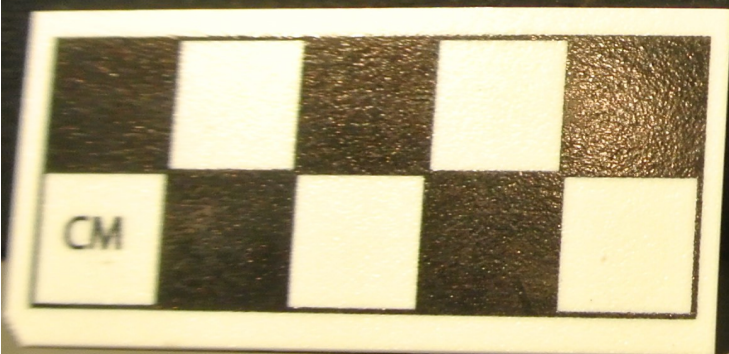

shop and obtain a beer license. (Is beer license for sale / of beer to fishermen, etc. OR for building of bar and restaurant????)

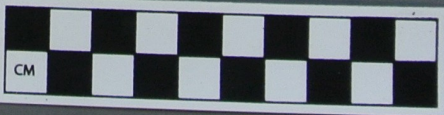
Smiths feel that since their property is definitely residential with ^{grown} plantings of many rare tropical trees and shrubs.....some ~~new~~ experimentally,....
