INTRODUCTION

This survey was made in compliance with Monroe County ordinance #21, 1975, section 5, as part of the Cultural Resources Assessment request.

An archaeological survey was conducted to locate and assess the presence, perimeters and significance of a cultural resource site known as 8-MO-2 in this project.

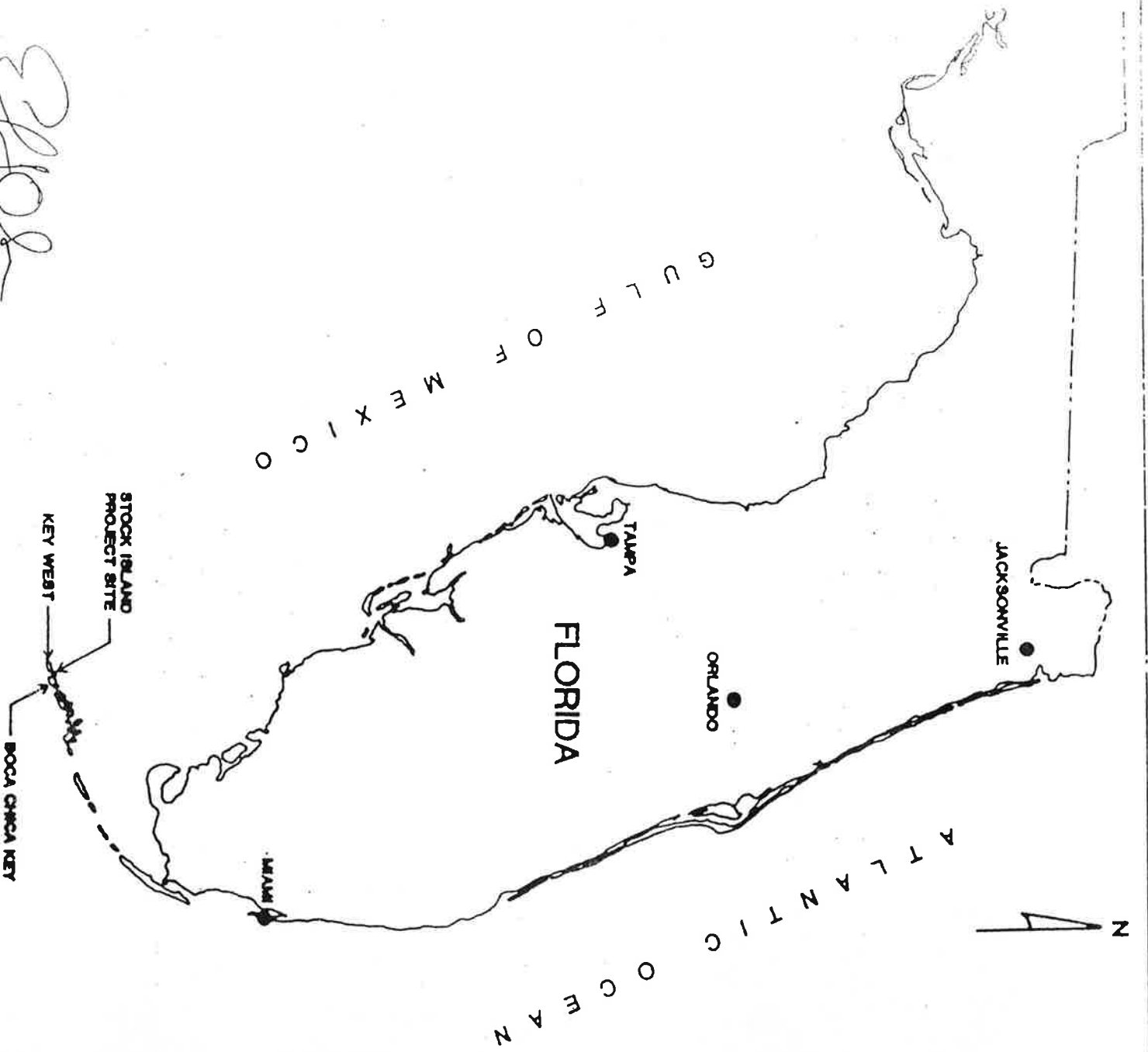
This was not a general survey, as a survey was conducted many years ago. At that time an aboriginal site was discovered and recorded as 8-MO-2. The purpose of the survey is to merely define the boundaries and depth of this site. This was accomplished by shovels hole testing. Holes were dug approximately every ten to twelve feet around the site, if black earth midden deposit, mixed with shell, bone or pottery was found; another test hole was dug outward from the center of the site. This process was repeated until a non-cultural deposit was found, thus indicating the boundary of the midden.

Bed rock was encountered between 15 to 50 centimeters.

LOCATION

This project is located northeast of Key West, on the west side of Stock Island. It juts into the Gulf of Mexico, known here as the Bay of Florida. The old Country Club Road is the boundary on the Stock Island side of this project. It is located in section 27, township 67 south, range 25 east.

The location of this project can be found on the Key West and Boca Chica quadrangle maps at latitude $24^{\circ}34'20''$, longitude $81^{\circ}44'30''$, and contains 112 acres, but is easier to find on the Inter-coastal Waterway map, Sugarloaf to Key West, #11445.
