## President's Day or Washington's Birthday?

In 1968 legislation was enacted that affected several federal holidays, one of which was Washington's Birthday. This act which took effect in 1971, was designed to simplify the yearly calendar of holidays and give federal employees some standard three-day weekends in the process.

President Richard Nixon issued a proclamation stating that from that year forward (1971), "President's Day" commemorating the birthdays of both Presidents Washington and Lincoln would be celebrated on the third Monday of February, as well as to honor all past presidents of the United States. He did not realize that a proclamation did not super-

sede federal legislation.


Apparently neither did many citizens of the United States.

Officially the holiday is still Washington's Birthday. There are several states which have made this designation legal, which is their right to do so. However, they are in the minority.

The federal government does not legally celebrate a "President's Day". Each year there are bills introduced in both the house and senate to return the name of the holiday to Washington's Birthday to honor the first president of the United States as it was originally intended.
