AWARDS

The standard system shall be used. There will be only one First (blue); one Second (red); one Third (yellow); and one or more Honorable Mention (white) ribbons.

Tri-Color Award: Best blue ribbon in Classes 2, 3 and 4, represented by a blue, red and yellow rosette. Black-based Silver Urn Trophy.

Creativity Award: To a blue ribbon winner in Classes 1, 5 and 6. Material may be fresh and/or dried. A minimum of painted and/or contrived material may be used. Originality must be one of the categories used in the evaluation of exhibits, represented by a purple rosette. Wine Cooler Trophy.

PETITE AWARD #1

Silver Pitcher I Award: Best miniature in Class 7. Blue & White rosette. *SILVER PITCHER #1 TROPHY*

PETITE AWARD #2

Silver Pitcher II Award: Best small in Class 8. Blue & White rosette. *SILVER PITCHER #2 TROPHY*

Award of Merit: May be awarded to a name blue ribbon winner scoring 95 or more points in Horticulture Sections (as indicated in schedule), represented by an orange rosette.

Sweepstakes Award: One in Horticulture -- Silver Snifter Trophy, and one in Artistic Division -- Revere Bowl Trophy. For exhibitor winning the highest number of ribbon points in each division, represented by green and white rosette. Blue = 5, red = 4, yellow = 3, white = 2.

Horticulture Excellence Award: May be awarded to Horticulture exhibit judged finest in the entire Horticulture Division. Represented by green, orange and blue rosette. Tall Loving Cup Trophy.

General Rules for Both Horticulture and Artistic

1. Competition is open to any amateur or grower.
2. The exhibitor is allowed only one entry per class; as many classes as desired may be entered.
3. All exhibits must be in place by 9:30 AM March 25, 1994. The club will be open at 8:00 AM, to permit set-up of fresh displays.
4. Dry arrangements or any other exhibits which will not suffer from early placement should be brought in Thursday, March 24, 1994 between 10:00 AM and 5:00 PM.
5. Exhibits must not be removed before 4:30 PM, March 26, 1994.
6. Plants on the State Conservation List may be used if legally obtained or grown by exhibitor.
7. All decisions by the Judges are final.
8. Only authorized personnel will be allowed in the building after 9:30 AM on March 25, 1994 until the judges and clerks finish their duties.
9. The Upper Keys Garden Club will not assume liability for damage or loss of personal property or for personal injury.

Artistic Division Rules

1. Flowers and foliage used need not be grown by exhibitor, except as in General Rules #6.
2. Entries must be the work of the exhibitor.
3. Plant material used should be listed on a 3 x 5 card. Entrant may give an interpretation of the design.
4. Bases and backgrounds may be used in all classes. Backgrounds and fastening material must not be visible on opposite side of furnished space, except in Class 6, where drapings are permitted.
5. All Artistic Division backgrounds are 24" wide, 32" high and 15" deep, except Class 1 Las Vegas Class 6 Wild Thing Class 7 Little Bit and Class 8 Cards See Section A.
6. Wilted flowers should be replaced by 9:30 AM Sat. March 26, 1994.
7. Four entries in each Artistic Division.
8. No artificial flowers, foliage or fruit may be used in Class 1.
9. Any exhibitor not able to exhibit at show time must provide a substitute. This is to make certain each space is filled and that no designer will be penalized an award due to an omitted entry.

SECTION A. ARTISTIC DIVISION

- Class 1: Las Vegas Wild and Crazy Staged on pedestals, which are 14" x 14". Arrangement should not exceed 20" wide but should be a minimum of 36" high, may overhang pedestal. Dried and/or fresh materials permitted. Accessory permitted if desired. Emphasis on originality. Eligible for Creativity Award.
- Class 2: "Wild Weather" Line arrangement of all fresh materials. One or more accessories may be permitted. The containers or bases may be of any material, including those manufactured from wood, however, weathered wood is not permitted in any form. Arrangement may depict any desired weather system such as tornado, hurricane etc. Eligible for Tri-Color Award.
- Class 3: "Wild and Wonderful" All fresh green material. No Accessories permitted. All general requirements for Top Awards must be met. Eligible for Tri-Color Award.
- Class 4: "Wet and Wild" Underwater arrangement. All fresh material. Accessories permitted. Eligible for Tri-Color award.
- Class 5: "Wild, Wild West" All dried materials. Fresh plant material is not permitted in any form. One or more accessories may be permitted. Eligible for Creativity Award
- Class 6: "Where the Wild Things Grow" Wild jungle alfresco table arrangement. Materials fresh and/or dried. Drapings and accessories permitted. Background is 36" wide, 48" high and 18" deep. Eligible for Creativity Award.
- Class 7: "A Little Bit Wild" Miniatures not to exceed 3"x3"x3".
Group A -- All Fresh Materials
Group B -- All Dried Materials
Eligible for the Petite Award
- Class 8: "Wild Card" Small arrangement featuring wild cards or portions of wild cards. Arrangement not to exceed 8" high 5" x 5" deep.
Group A -- All Fresh Materials
Group B -- All Dried Materials
Eligible for Petite Award

Horticulture Division Rules:

"Not Quite So Wild"

1. Specimen plant containers should be neat, clean and free from mineral deposits. Either clay or plastic.
2. Potted plants must have been in exhibitor's possession for at least 90 days.
3. Leaves must be free of residue. but not oiled. No damaged leaves.
4. Entry tags must show botanical and common name. Failure to conform results in automatic 5 point deduction.
5. Containers will be furnished for cut specimens. Specimens not to exceed 18".
6. An exhibitor may make more than one entry in a class, provided that each entry is in a different section.
7. Cut specimens consist of 3 blooms to a container except one rose, one orchid or spray of orchids, one hibiscus and one gerbera. No exhibitor may enter more than 3 cut specimens.
8. Roses must be shown with foliage.
9. Judges may subdivide. More classes may be added.
10. All horticulture entries, except cut specimens, MUST be brought in on Thursday, March 24, 1994, between 10:00 AM and 5:00 PM. Only cut specimens will be received March 25, 1994 between 8:00 AM and 9:00 AM.

(6) ADHERENCE TO SECTION 6 OF THE ENDANGERED SPECIES ACT. - The Endangered Species Act of 1973, as amended, promulgated by the U.S. Congress, classifies species of plants as endangered or threatened and places certain limitations on removal of these plants from the wild:

(a) Those plants listed as endangered under the Federal Endangered Species Act of 1973, as amended, are restricted in collection, movement, and handling under this statute to conform with the regulations of the Endangered Species Act, and rules and regulations of the United States Department of the Interior regarding endangered plants. Those plants listed as endangered on the federal list, and known to be established in Florida are:

1. *Amorpha crenulata* (Miami lead plant).
2. *Asimina tetramera* (four-petal pawpaw).
3. *Bonamia grandiflora* (Florida bonamia).
4. *Cereus ereophorus* (Indian River Prickly-apple).
5. *Cereus robinii* (tree cactus).
6. *Chamaesyce deltoidea* (*Euphorbia deltoidea*) (Rockland spurge).
7. *Chionanthus pygmaeus* (pygmy fringe-tree).
8. *Chrysopsis floridana* (Florida golden aster).
9. *Deeringothamnus pulchellus* (white squirrel-banana).
10. *Deeringothamnus regelii* (yellow squirrel-banana).
11. *Dicerandra cornutissima* (Robin's mint).
12. *Dicerandra frutescens* (Lloyd's mint).
13. *Dicerandra immaculata* (Olga's mint).
14. *Eryngium cuneifolium* (scrub eryngium).
15. *Galactia Smallii* (Small's mikpea).
16. *Harperocallis flava* (Harper's beauty).
17. *Hypericum cumulicola* (highlands scrub hypericum).
18. *Lupinus aridorum* (McFarlin's lupine).
19. *Paronychia chartacea* (papery Whitlow-wort).
20. *Polygala smalii* (tiny polygala).
21. *Polygonella basiramia* (tufted wireweed).
22. *Prunus geniculata* (scrub plum).
23. *Rhododendron chapmanii* (Chapman's rhododendron).
24. *Torreya taxifolia* (Florida torreya).
25. *Warea amplexifolia* (clasping warea).
26. *Warea carteri* (Carter's warea).
27. Any other species of plants known to be established in Florida, which may be added to the Federal Endangered Species endangered plant list.

(b) Those plants listed as threatened under Section 6 of the Federal Endangered Species Act of 1973, as amended, are restricted in movement, and handling, under this statute to conform with the regulations of the Endangered Species Act, and rules and regulations of the U.S. Department of the Interior regarding threatened plants. Those plants listed as threatened on the federal list, and known to be established in Florida, or any species of plants known to be established in Florida which may be added to the Federal Endangered Species threatened plant list.
