I talked to Edna and she is not aware of any such number. I looked it up on line (See http://www.800helpfla.com/socbus.html#laws) and also checked the corresponding Florida Statute. It appears we'd fall into the Charitable organization category.

The law referred to used this definition: "Charitable organization" means any person who is or holds herself or himself out to be established for any benevolent, educational, philanthropic, humane, scientific, artistic, patriotic, social welfare or advocacy, public health, environmental conservation, civic, or other eleemosynary purpose, or any person who in any manner employs a charitable appeal as the basis for any solicitation or an appeal that suggests that there is a charitable purpose to any solicitation. It includes a chapter, branch, area office, or similar affiliate soliciting contributions within the state for a charitable organization which has its principal place of business outside the state."

So I anonymously called the dept. When I said we don't do soliciting, he said if we charge for the garden walk and call it a donation, we fall under this category. It sounds like we should have had this registration all along. (I think that is why there was that lengthy wording that I showed you on that Marathon GC poster.)

I'm not familiar with what filings and tax returns we do now but the appl. asks for our 990 and financial statement. A registration number is mandatory on the TDC grant application and it sounds like is necessary for us to be legally soliciting donations.

The FFGC as well as the Marathon GC and the Key West GC are listed as having registration numbers. Do you know someone in those clubs that you could call to ask about this process? I don't want to raise awareness of us in Tallahassee if we don't need to.
