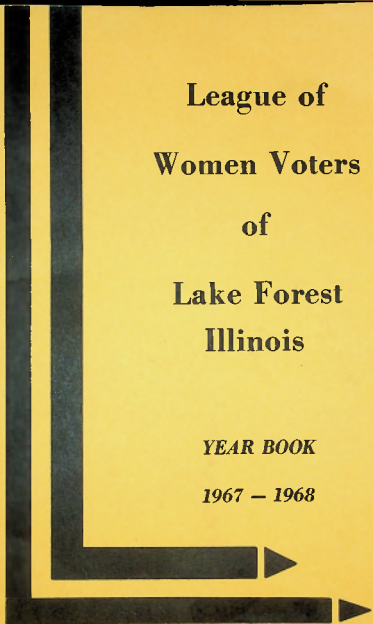

Through its Program the League gives sustained attention to and takes concerted action on issues chosen by the members.

Through its Voters Service the League provides nonpartisan factual information on the structure and functions of government and of the political parties, and on voting procedures, election issues, and candidates.

LOCAL CURRENT AGENDA

1. Study and evaluation of methods of financing the City of Lake Forest to implement the 1955 City Plan as amended.
2. Study and evaluation of public education for Lake Forest including the elementary schools, the high school and a junior college.
3. Study and evaluation of the structure and financing of Lake County government with action as indicated.
4. Support for retention, expansion and sound administration of Forest Preserve lands.

LOCAL CONTINUING RESPONSIBILITIES

1. Publication of the handbook, "Facts for Lake Foresters."
2. Support of measures which promote good human relations in Lake Forest.

STATE PROGRAM

- I. Study and action to revise the structure of Illinois government, to include:
 1. A Constitutional Convention for Illinois;
 2. A Study of the Legislative and Executive articles;
 3. A new Revenue Article and measures to obtain an adequate and flexible tax structure;
 4. Annual Sessions for the Illinois General Assembly;
 5. A Short Ballot, electing the only policy making officials;
 6. Improved and clarified Election Laws and Procedures;
 7. Protection of the 1962 Judicial Amendment and support of measures to further judicial reform.
- II. Protection of the Individual in his civil rights and liberties:
 1. Support of state legislation to provide equal housing opportunities;
 2. Support of legislation to equalize employment opportunities;
 3. Preservation of constitutional liberties.

III. Support of improved local, regional and statewide welfare services by Illinois state agencies serving children and their families.

IV. Study of local governmental structure within Illinois.

NATIONAL CURRENT AGENDA

Development of Human Resources: Support of policies and programs in the United States to provide for all persons equality of opportunity for education and employment.

Foreign Policy: Evaluation of United States with the People's Republic of China. Support of U.S. policies to enhance the peace keeping and peace building capacities of the UN system and to promote world trade and development while maintaining a sound U.S. economy.

Water Resources: Support of national policies and procedures which promote comprehensive long-range planning for conservation and development of water resources and improvement of water quality.

NATIONAL CONTINUING RESPONSIBILITIES

Apportionment of State Legislatures: Support of apportionment of both houses of state legislatures substantially on population.

District of Columbia: Support of self-government and representation in Congress for citizens of the District of Columbia.

Loyalty-Security: Support of standardized procedures, "common sense" judgment, and greatest possible protection for the individual under the federal loyalty-security programs; opposition to extension of such programs to non-sensitive positions.

Tax Rates: Opposition to constitutional limitation on tax rates.

Treaty Making: Opposition to constitutional changes that would limit the existing powers of the Executive and the Congress over foreign relations.
