1954-55 IN REVIEW

The activities of the Lake Forest League of Women Voters for t e pas year, un er rs. John C. Christie as President and Mrs. Robert O. Lehmann as Vice-presi en, ave een stimulus to the membership and a service to others.

SERVICE TO THE COMMUNITY

In summarizing these activities, we should like to stress especially those that contributed to the community.

The Public Affairs Institute on World History and World Trade, held last November 21 and 22 in conjunction with Lake Forest College and the Chicago Council on Foreign Affairs, was declared an outstanding success, with about 800 persons participating. Four stimulating speakers led discussion at the daytime sessions, and Arnold J. Toynbee and Paul G. Hoffman spoke at the evening meetings.

In preparation for the State Reapportionment Referendum last November. Constitutional Revision Chairman Mrs. George R. Steiner, Co-chairman Mrs. George B. Rogers, and an active committee undertook the task of informing Lake Forest of the urgent need to "Vote YES on the Blue Ballot." This they did through workshops, a public evening meeting, League speakers provided for numerous local groups, newspaper publicity, posters, a Voters' Service meeting, and a tag day. Their reward was the success of the referendum. Locally it passed 44 to 1.

In connection with the activities already mentioned, the services of four other chairmen should be noted. Mrs. Joseph G. Mosey, Publicity Chairman, has provided 534 inches of excellent copy, two covers, and three other pictures in the Lake Forester, besides generous coverage also in the Waukegan News-Sun.

Mrs. William S. North, Voters' Service Chairman, and Mrs. Walther H. Buchen, Co-chairman, were also active in providing information relevant to the November election at the regular November meeting, and also for the use of Barat College. As a service to voters, Mr. Owen Lindsay, president of the Lake Forest Board of Education, was invited to speak at the April meeting to explain the need for the April 16 school referendum.

Twice this year the Voters' Service Committee has sent members to Waukegan to the Court Court House to help with the ceremony at which final citizenship papers are granted. They have welcomed the new citizens, helped them register to vote, and given each a LWV booklet on citizenship. Those who have assisted are Mesdames W. H. Buchen, A. C. Bell D. M. Pope, R. E. Soiel, and S. Vinje.

Mrs. Solomon B. Smith, Public Relations Chairman, has worked with various other chairmen in reaching the public. She was instrumental in arranging to have our bulletin printed by The Northern Trust Company. We are grateful to both Mrs. Smith and The Northern Trust

Publications Chairman Mrs. Richard Bentley, assisted by Mrs. Kenneth O. Birne, acquainted nonmembers with excellent pamphlets put out by the national League, through phlet booths at the Public Affairs Institute and through providing these materials to the schools to help prepare for their participation in the Institute. Mrs. Bentley also has to call public attention to LWV publications through regular displays in the Market S window of Margaret Wells' office. The national LWV pamphlet, Parliamentary Proc dused in the course on parliamentary law that Miss Frances Whedon gave last fall for hitry girls from Barat College.

Mrs. Richard Bentley and Mrs. Sidney G. Haskins, Co-chairmen of Conservat n, ith t assistance of several members of their committee, presented a panel discussion "From Compost to Congress" at meetings of the Highland Park Garden Club and the Lake Forest Garden Club.

Facts For Lake Foresters, the Lake Forest League's handbook was issued in November under the chairmanship of Mrs. Alexander C. Bell, assisted by Mrs. George B. Rogers and Mrs. Robert E. Spiel. About 2500 copies were mailed to Lake Forest families, and 350 were distributed to schools. The Lake Forest Chamber of Commerce has recently requested copies to send to each new family moving here, believing Facts For Lake Foresters to provide an exceptional means of acquainting people with the community.

The local League takes pride in these services to the people of Lake Forest. It is also happy to report that good relations with the community are a two-way matter. The League's finance drive, under the chairmanship of Mrs. Herbert P. McLaughlin, exceeded its goal, raising more this year than ever before.

AGENDA ITEMS STUDIED

International Relations Chairman Mrs. Edward K. Welles and her committee were of great service to the Public Affairs Institute by holding two well-organized workshops on world trade with over twenty people taking part. Mrs. Robert G. Andrus and Mrs. Clymer S. Bowen were leaders in these discussions, which provided background for the Institute. Mrs. Welles, Mrs. Andrus, and Mrs. John S. Nagel concluded the year's study with a United Nations, World Trade, and Bricker Amendment quis at the June general meeting, bringing the members up-to
on national continuing responsibilities.

Six members of the International Relations Committee assisted the state League in its part of the national World Trade Survey this spring by interviewing heads of six Lake County manufacturing firms. This project will present a comprehensive survey of the opinions of producers in regard to the favorable or adverse effects of foreign trade on their own businesses specifically. Agriculture and mining are being covered as well as manufacturing. Results are being tabulated by a statistical research firm. In the Chicago metropolitan area all firms employing 250 or more have been approached, and in the rest of the state, all those employing 100 or more. The results of the survey in Illinois will be published soon and the results sent to our Congressmen. Those of our members who helped interview are Mesdames Robert G. Andrus, Richard pentley, Francis A. Merckx, George L. Reilly, John S. Nagel, and Edward K. Welles.

The Constitutional Revision Committee, under Mrs. George R. Steiner and Mrs. George B. Agogers, has been mentioned for its community service in connection with Reapportionment. In addition, three workshops were held to study the Judicial Amendment, and the March general meeting was planned. Mr. William Trumbull, member of the Bar Associations' Joint Committee, spoke on the subject.

Mrs. McPherson Holt, Welfare Chairman, and Co-chairman Mrs. Keith Carpenter provided the speaker for the December general meeting. Mary Jane Ward, author of The Snake Pit, gooke on the topic, "Mental Health is the Voters' Problem."

Mrs. W. Press Hodgkins doubled as Chairman of Home Rule and of Suburban Relationship to Chicago. In the former capacity she conducted a workshop on Home Rule; in the latter, she arranged the October meeting at which Mrs. Bradford L. Patton, President of the Citizen Information Service (an educational arm of the state League), and Mrs. Ben P. Freeman, a state League resource chairman, spoke.

In January, Mrs. Robert O. Lehmann arranged a panel presentation of state continuing in January, Mrs. Robert O. Lehmann arranged a panel presentation of state LWV president. Mrs. Frank fixon drew on her long interest and experience in the League to introduce the panel. The presentation was followed by discussion and adoption of recommendations for the new state agenda.

On the local level, fourteen members participated in the two workshops on Lake Forest Recreation, conducted by the chairman, Mrs. Roger A. Baird and co-chairman, Mrs. Lawrence L. O'Connor. In February they arranged for Mr. Donald McKellar, president of the Lake Forest Recreation Board, to speak to the general membership on the accomplishments and plans of the Board.

The new local agenda item, City Planning, provided the subject for the May meeting at which Mayor Elliott Donnelley spoke. The mayor discussed population trends, new zoning provisions, and revealed plans for the future of Lake Forest. Mrs. Solomon B. Smith, City Planning Chairman, arranged the meeting.

SERVICES TO MEMBERS

The success of Mrs. George L. Reilly's three bulletins this past year prompted the decision to make them monthly in the future. The present editor appreciates the groundwork laid by Mrs. Reilly.

The Lake Forest League is indebted to Mrs. Clymer S. Bowen, Treasurer, for her painstakens, accurate accounts; and to Mrs. Robert E. Spiel, Secretary, for her clear, correct minutes, and appreciates their continuing to serve in these capacities.

For the many mailings she has sent out, the League wishes to thank Mrs. Howard Roberts and her occasional assistants. For reaching the membership when it was necessary it thanks Mrs. Walther H. Buchen and her telephone committee.

For helping make its meetings pleasant occasions, the League expresses its appreciation to Mrs. David P. Cordray, Social Chairman, to those who assisted her as hostesses, and to those who opened their homes for meetings.



OCTOBER THIRD MEETING

"Conditions of Freedom" will be the topic of Dr. John B. Johnson, Jr., President of Milwaukee-Downer College, when he speaks on Monday, October 3, at the opening meeting of the League of Women Voters. This meeting has been planned by the Individual Liberties Committee, under Mrs. David W. Stickney, as an introduction to the theme, "Principles of American Liberty," which will be developed in community study groups this fall.

Several members of the Lake Forest League of Women Voters heard Dr. Johnson speak last spring at the regional meeting of the National League, conducted by Anna Lord hrauss, former national president. These members were enthusiastic about wanting our eral membership to hear him.

FISCAL STRUCTURE WORKSHOP Of great concern to League members throughout Illinois is the first item on the new state agenda: basic constitutional revision to provide for a co-ordinated and flexible state fiscal structure. Thoughtful study of this item is essential preparation for intelligent action at the time of the next legislative session. The Lake Forest League of Women Voters recognizes this fact in starting its year's study program with a series of workshop meetings on fiscal structure .

On October 10 at 1:45 p.m. at the home of Mrs. Granger Brown, chairman, the Committee on Revision of the Revenue Article will hold its first workshop meeting. Discusaion at this first session will center on new Illinois taxes, a recent amendment to the revenue article, and a brief comparison of the tax systems of other states with that of Illinois. Three meetings are planned, probably all in October. For the January general meeting this committee expects to provide a speaker. Just before that time. they will hold a review workshop. Members of the planning committee are Mesdames Norman R. Anderson, Robert O. Lehmann, Arthur G. Rooney, Calvin D. Trowbridge, and Mrs. Granger Brown, chairman.

PRINCIPLES OF AMERICAN LIBERTY



- Study of and support for a long-term governmental policy for the conservation of renewable natural resources, with emphasis on the co-ordination of governmental agencies involved.
- Support of U.S. trade policies that will help solve national and international economic problems. (This is a continuation of present item.)
- 3. Study of proposed means of development and peacetime uses for atomic power; the extent to which knowledge and techniques should be shared with other nations, and development subsidized. These items were recommended in the order listed above.

In February the National Board will submit to all local Leagues a proposed agenda based entirely on the recommendations they receive this month. Final adoption will be made at the national convention next May after still further consideration at the local level.

At our last meeting the motion was also made and passed that the topic under Item Two on our Current Agenda be placed on Continuing Responsibilities in 1956-58 as: "Protection of our individual liberties as established in the Bill of Rights and consonant with the public interest."

NEW MEMBERS ORIENTED

Two meetings were held during November by Mrs. George R. Steiner, Membership chairman, assisted by Mrs. John W. Suter Jr., to orient new members. At the first meeting a skit prepared by the State League explained the workings of the various branches - local, state, and national; and an additional explanation was made of our local Lake Forest agenda. At the second meeting Mrs. Frank P. Hixon spoke on the history of the League of Women Voters, and Mrs. John C. Christie, President, explained program making in the League.

If there is need for this sort of orientation program again later in the year, it will be repeated, as it is an invaluable introduction to League membership.

FINANCE CAMPAIGN

The Finance Committee of the Lake Forest League of Women Voters, under the chairmanship of Mrs. Herbert McLaughlin, is delighted with the gratifying returns. However, member contributions are still about two hundred dollars short of last year's total, and it is hoped that more members will respond.

JANUARY NINTH MEETING

On January 9, the Lake Forest League of Women Voters will present Mr. Kemeth Clapper, an attorney from Danville, speaking on the proposed amendment to the revenue article of the state constitution. This amendment will appear on the familiar Blue Ballot at the general election in November of 1956, and it poses the question for all Illinois citizens to decide: whether to give the General Assembly the responsibility for making our tax structure more modern or, by voting down the amendment, to keep it the way it is.

This program has been arranged by the Committee on State Fiscal Structure under the chairmanship of Mrs. Granger Brown.

In essence the amendment would substitute a classified property tax for the present uniform general property tax. Arguments pro and con classification are both sound and plentiful, Very briefly here are a few of them.

Con: Giving the legislature the power to classify property for taxation is giving them a "blank check" to impose any kind of tax. (The amendment expressly forbids imposition of a graduated income tax.)

Pro: Since the legislature is the fiscal

authority of the state, and elected by the people to represent them, it should be free to impose such taxes as it feels necessary.

Con: The present tax structure creates an atmosphere favorable to industry and should not be changed.

Pro: The present tax structure favors regressive taxes to raise state revenue. It also promotes individual and corporate dishonesty.

Con: Giving the legislature power to classify property by law merely legalizes presently accepted extra-legal practices.

Pro: By permitting taxation by other-thanproperty-value methods, the property tax could be replaced by others adapted to tap modern forms of wealth. And by setting up classes of property by law, the same assessment standards would be required throughout the state if and when property is to be taxed by value,

The League must decide by spring its position on this amendment and, in line with its purpose, it must also give other citizens information on which they may base their decisions. Mr. Clapper is expected to help us do both these things.

Washington 25, D. C., asking her to use her influence to get H. R. 5550 onto the floor of the House, and expressing your interest in her support of the measure.

LEAGUE RECOGNIZES LAKE COUNTY HEALTH NEEDS

Improved county health services are one of the continuing responsibilities of our League; therefore, we are much interested in a movement to place a referendum on the November ballot for the establishment of a Lake County Health Department. Petitions are being circulated throughout the county to make this possible. You may have an opportunity to sign one; if so, you may feel assured that such a measure is in accord with the League's position.

The Illinois Department of Public Health considers a county health department to be the most effective and economical governmental unit for the provision of good public health services. These include disease prevention through immunization, improved sanitation, and education carried on by a full-time health officer, public health nurses, and other specialists.

Six years ago a similar measure was defeated by a narrow margin. Opponents feared an increase in the tax rate. The maximum tax that could be levied for a county health department would be a half mill. Proponents of the current proposal feel that a quarter mill would be adequate.

According to a recent article in the Waukegan News Sun, a study of Lake County's public health situation is now being made by the Lake County Medical Society. Our League will look forward with interest to the publication of such a report.

SERVICE TO THE COMMUNITY

In preparation for the primaries in April, Mrs. Walther H. Buchen, Votera Service Chairman, and her co-chairman Mrs. Willard N. Boyden, called together League members responsible for this work in Lake Bluff, Waukegan, Barrington, and Highland Park. They shared the very interesting job of interviewing candidates for state and county offices. From the information gathered, they published a four-page spread in the Lake Forester and Highland Park News; and articles appeared in the Waukegan News-Sun. Mrs. Buchen conducted two workshops for our members based on the pamphlet Political Parties - U.S. A., which revealed to us how much we did not know about the function of political parties. A tour annual meeting, Mrs. Raymond S. Simons spoke on the topic "Behind the Scenes at a Political Convention." Other activities of the Voters Service Committee included giving information on voting procedures to new citizens at the time they received their naturalization papers in Waukegan; and setting up at the request of the Forest city officials, a telephone committee to help get the voters out for a special election of alderman.

The Chamber of Commerce and the City Manager requested extra copies of Facts for

Lake Foresters to give to new residents.

A booklet describing the United Nations, its problems, and its achievements, was distributed

among the schools in observance of United Nations Day in October.

In response to a request from the Junior Woman's Club of Lake Forest, Mrs. Roger Baird

spoke at their meeting in March, describing the principles and program of the League.

Publicity for all League projects was again expertly handled by Mrs. Joseph G. Mosey.

Thirty-five of her excellent articles appeared in the Lake Forester, plus eight pictures. She arranged to have a cover, designed under the direction of Mrs. Solomon B. Smith for the Freedom Agenda project, appear on a September issue. In addition, seventeen articles and

thirteen pictures were published in the Waukegan News-Sun.

More than 120 Lake Forest men and women took part in seven Freedom Agenda discussion groups. Several other organizations in Lake Forest co-operated with us in publicizing the project; one of the groups was organized and conducted by members of the local branch of the American Association of University Women, and their husbands. All groups studied the six FA pamphlets; and several so enjoyed the discussions that they continued to meet to study other subjects as well. This was due primarily to the skillful guidance of the discussion laders who stimulated the expression of diverse points of view. Mrs. David W. Stickney, Chairman of FAP, shes to express her deep appreciation to the leaders and to the hosts and hostesses who raciously provided hospitality to the groups.

Problems of World Trade were considered in workshops led by Mrs. Charles F, Glore, Jr Chairman, and Mrs. Robert G. Andrus, Co-chairman, with the co-operation of Mrs. MacPherson Holt who was in charge of the national Continuing Responsibilities in the field of international relations. In February, Mr. John F. Fennelley spoke to us on "Problems of World Trade Facing the Eighty-fifth Congress." Publication of the Illinois Trader and Facts and Attitudes on World Trade which summarized the results of League trade surveys, were of special interest to our members, particularly those who took part in our share of the survey by interviewing farmers and manufacturers last spring.

Mrs. Granger Brown, Chairman of the state item on Revision of the Revenue Article, led eight workshops on fiscal structure, with the assistance of her committee. At our January meeting, Mr. Kenneth Clapper, a lawyer from Danville, spoke on the proposed amendment which will appear on the Blue Ballot in November. A consensus of all local Leagues in Illinois resulted in the decision that the League will actively support the amendment.

In preparation for the meeting in December when Mr. C. C. Case, Recreation Director for Lake Forest, reported on the achievements of the Department, Mrs. Edward K. Welles as chairman of our local Recreation item, scheduled a workshop at which the background of the recreation program in Lake Forest was reviewed. She pointed out that most of the League recommendations have been acted upon by the Recreation Board.

Mrs. Solomon B. Smith, Chairman of the second local agenda item, City Planning, secured Mr. George R. Beach, Jr. to speak to us in March on the "Official Plan for the City of Lake Forest." Mr. Beach's talk was an interesting follow-up of Mayor Donnelley's talk in May '55 on City Planning, arrangements for which were also made by Mrs. Smith.

SERVICE TO MEMBERS

Under the leadership of Mrs. George R. Steiner, Chairman, and Mrs. John W. Suter, Jr., Co-chairman, the Membership Committee arranged 'bring-your-sandwich' luncheons for new members and guests, preceding each general meeting. These have proved to be a very pleasant way of meeting newcomers. As a result of the luncheons and of three orientation workshops last fall, new members have become more active in League work than ever before. A questionnaire was sent to all League members early in the year, and a card file of each one's interests in League activities has been kept up to date.

Mrs. David P. Cordray, Social Chairman, and those who have assisted her as hostesses, have provided delicious refreshments, and have helped to make general meetings pleasant as well as informative occasions.

Mrs. Herbert P. McLaughlin once again directed the Finance Drive with outstanding success, exceeding the quota by an even larger amount than last year.

The chairman of Publications, Mrs. W. Press Hodgkins, was kept especially busy with the sale of League publications to members and to participants in the Freedom Agenda groups. Sales far exceeded any previous year.

The Telephone Committee headed by Mrs. Frank A. Zillmer gave important assistance to both Membership and Voters Service chairman.

Our League was privileged to hear this enlightening discussion at our November meeting. The National Convention has now placed a conservation item on the program for the next two years.

Mrs. Roger Baird has made this bulletin so complete and yet so readable each month that the present editor must (and will) strive to maintain its high editorial standards. We shall miss Mrs. Baird sorely, and commend her to the League in Neenah-Menasha, Wisconsin.

Mrs. John C. Christie, president for the past two years, says her Board has been outstanding; every Board member has shown an unusually active interest in all League work. The new president, the new Board, and your new editor say that the successes reported above would not have been possible without Mrs. Christie's splendid leadership.

"The League of Women Voters is dedicated to the principles of self-government established in the Constitution of the United States," These words are the first ones appearing on the League's national program; they truly define the purpose of the League.

Dr. Erich Fromm in The Sane Society submits that today society is not sane, but "alienated." Among other remedies he proposes is a new procedure for the demo-cratic system: 1) political decisions must be made in groups where people have personal contact with each other and where issues are discussed thoroughly; 2) citizens must have vital facts which enable them to make reasonable decisions; 3) whatever each citizen decides must have a direct influence on the central executive.

This is the essence of the League's program-making process. The process begins with suggestions to the state board from local Leagues and individual members. After sifting and combining many ideas into the several which have the widest support, the state board sends them back for reconsideration by the local Leagues, who then send in their second round of recommendations. At last there emerges the Proposed State Current Agenda for final action by the Illinois LWV convention next spring.

Self-government requires personal responsibility for political decisions. To vitalize that process the League has evolved the above procedure for making its program, a process to which every member has her personal responsibility.

LAKE FOREST'S PROPOSALS FOR THE STATE CURRENT AGENDA

- Support for basic revision of the judicial article of the Constitution to provide for court reorganization and nonpartisan selection of the judiciary.
- Support for a short ballot and improved election procedures.
- Study of the desirability of annual session of the state legislature.
- 4. Study of and support for improved administration of state conservation agencies.
- istration of state conservation agencies.

 5. Study of the reorganization of county and township government.

The wording of these proposals was done by a small committee after the members agreed at the December 3rd meeting on these specific areas of interest. They will be submitted in this form to the membership for their approval at the January seventh meeting.

It was agreed to recommend that only two items be placed on the State Current Agenda when it is finally adopted by the Convention, All members present approved items 1) and 2) above, and two-thirds recommended items 4). A minority recommended items 4) and 5).

The consensus was that the following be added to State Continuing Responsibilities:

Basic constitutional revision to provide for a co-ordinated and flexible state fiscal structure.

PROPOSED LOCAL CURRENT AGENDA EXPLAINED

The local Current Agenda for 1957-1958 which will be presented for adoption at the April 8th meeting, consists of two items:

- (2) A study of the home rule powers granted to the City of Lake Forest by its charter, with possible appropriate action.

County government is the form of government that has had the least study. It has been called "the dark continent of politics." The present complicated township county relationship was useful in the early days; but many people feel that we have outgrown some of its features.

A study of home rule powers would be a study of the basic authority for Lake Forest city government: the powers granted by the city charter, and the differences between operation under special charter and under other legislative acts. This would include a fundamental difference - that of the authority for the administration of our public schools.

LIBERTY AND SECURITY

Is the federal loyalty-security program adequate, and does it also preserve our basic American traditions of justice and individual liberty? In developing a system which will defend the country against the Communist conspiracy and at the same time establish fair procedures to safeguard the individual, the interrelation of these two concepts of liberty and security must be considered.

Our government has put into operation various loyalty and security programs since 1946 to combat the danger of Communist infiltration and subversion within the country. The current internal security program is designed to prevent acts which are against the public interest, "to insure that the employment and retention in employment (of individuals) is clearly consistent with the interests of the national security". The program affects five strategic areas; federal departments and agencies, the Atomic Energy Commission, defense industries, port security, and military personnel. Ten million people are directly involved. The basic regulations, criteria, and clearance procedures vary considerably, so that they are generally treated as five separate programs under the Eisenhower administration. These have been studied by a special committee of the Association of the Bar of the City of New York, on which Mr. Richard Bentley was invited to serve. The Committee has published an authoritative and complete report of its findings which will be the subject of Mr. Bentley's talk at our regular meeting on Monday, May

Voters Service and the Revenue Amendment

Voters Service had an active year providing information on candidates, and helping the Revenue Amendment Committee.

At the County Fair in July, we co-operated with the other Lake County Leagues in setting up a booth where posters, literature, and a tape recorder emphasized the advantages of the Revenue Amendment. Sandwich boards prepared by Mrs. William D. Frost, and paper hats by Mrs. Robert Williams were paraded about the grounds. Assisting during the four days were Mesdames Anderson, Brown, Buchen, Frost, Rooney, Spiel, and Williams. Just preceding the election the same sandwich boards were displayed in Lake Forest, and pamphlets and fliers were distributed.

The October and November general meetings were devoted to candidates and to discussion of the Revenue Amendment.
Mrs. Ronald J. Christie, LWV State Chairman for the Revenue Amendment spoke at the October meeting, and the views of the candidates for State Senator and State's Attorncy were heard. Reports of interviews with other candidates were given at the November meeting by Mesdames Addington, Bazeley, Beidler, Glore, Jehmann, Mason, Steiner, Templeton, Wilson, and Mrs., William S, North,

co-chairman of Voters Service.

As part of the get-out-the-vote campaign, posters were placed on Western Ave. lamp-posts bearing the caption "Vote but Don't Vote in the Dark". A photograph appeared simultaneously on the cover of the Lake Forester. Mrs. Kenneth Weld and her committee prepared a four page insert in the pre-election issue devoted to information on the candidates. This insert also appeared in the Highland Park, Highwood, and Deerfield papers, and was distributed in Libertvoille.

In December the Lake Forest League again participated in the naturalization ceremonics for new citizens in Waukegan. Sixty-four were welcomed, and those eligible to vote were assisted in registering.

In addition to the activities outlined above, talks on the Revenue Amendment were given to eight organizations in Lake Forest; and seven articles were submitted to the Lake Forester.

A series of six radio broadcasts arranged by this committee was given over Station WKRS on Tuesday afternoons, by courtesy of Barat College. Speakers on these programs were Mr. Ray Nicholas, Director of the Lake County Farm Bureau; Mr. James F. Oates, Jr., president of the Peoples Gas Light and Coke Co.; Mr. John T. Pirie, Jr., chairman of the Citizens' Blue Ballot Information Committee; and a panel of League members.

Although the Amendment failed to pass, it is consoling to know that it lost by a smaller margin in Lake Forest than in surrounding areas.

County Health and other Local Continuing Responsibilities

Under local Continuing Responsibilities and the chairmanship of Mrs. McPherson Holt, the League favored the referendum for the establishment of a Lake County Health Department which was passed by the voters in the November election.

Also under local CRs, a state bill to abolish special charter provisions applicable to school districts was studied in two workshops led by Mrs. Maurice R. Eastin. The Lake Forest League could not act officially, since this was a state measure; but members could and did oppose the bill as individuals by writing our legislators. An important local responsibility of League members is attendance at City Council meet ings which are held on the first Monday evening of each month at eight o'clock at City Hall. Mrs. Solomon B. Smith, chairman of Public Relations, and Mrs. Granger Brown have been faithful attenders, and they urge other members to join them.

NATIONAL AND STATE AGENDA ITEMS

Individual Liberties

In the study of the League's national agenda item on Individual Liberties "Evaluation of the federal loyalty-security programs" - two workshops were held this spring based on extensive study by members of the committee. At the May general meeting, Mr. Richard Bentley gave a full and objective explanation of the Report of the Association of the Bar of the City of New York and its recommendations for improvement of the federal loyalty-security programs. Mr. Bentley was one of the out-of-town lawyers associated with the report.

Conservation

A study of water resources was presented in three workshops in November by members of the Conservation committee, each of whom chose one aspect of this broad field to provide a background for future study. In February, the general meeting of the League was jointly sponsored by the Garden Club to hear Mr. Richard J. Costley, Regional Forester in Milwaukee for the U.S. Department of Agriculture. Mr. Costley discussed water problems, present and future.

International Relations

The League's continuing interest in International Relations was ably demonstrated by Mrs. Oscar M. Ruebhausen, Observer at the U.N. for the National Board, when she spoke to us in September on United Nations progress in settling world disputes, and the special relationship of its Technical Assistance Program to the United States' Point Four Program.



Two calls for action were sent out by the National Board during the year -- one for support of the bill to authorize United States participation in the Organization for Trade Co-operation; and one which came on

a hot Sunday afternoon in July calling for urgent action to get appropriations restored for support of the U.N. Technical Assistance Program. All Board members were telephoned in each instance and asked to call ten members to write Congressmen - and to ask husbands to do the same. In the first instance, Mrs. Church, our representative, was written in the name of the League by the President, and she immediately replied that she was wholly in support of the bill. In the second instance the President sent a wire to Sen. Dirksen in the name of the League.

In November, a memo from Mrs. Lee asked that Leagues attempt to direct public thinking toward long range solution of the urgent and dramatic problems of foreign policy; and that each League develop a method best suited to its community. Under this Focus on the Future program, five discussion groups were organized in January by Mrs. Charles F. Glore, Jr. to include both League members and husbands, and many others. The groups met regularly at intervals most convenient to each. All started with the Eisenhower Doctrine, for which a background fact sheet was prepared.

At the Annual Meeting Dr. Herman Finer of the Political Science Department of the University of Chicago spoke on "Some Implications of the Elsenhower Doctrine". Dr. Finer found the questions following his talk so interesting that he stayed an hour longer than he had intended.

Dr. John A. Wilson, Andrew MacLeish Distinguished Professor of Egyptology and head of the Oriental Institute at the University of Chicago, spoke in the evening of April 23 at Mins Lilace Barnes' house to about one hundred members of the discussion groups and their friends. It was a brilliant, profound, and objective analysis of the complex emotional, prolitical, geographical and historical problems of the Middle East.

Judicial Amendment

Three workshops to study the present court system in Illinois and the recommendations of the Chicago and Illinois State Bar Associations in the form of an amendment to the Illinois Constitution, were held in January. At the League's general meeting that month, Rep. Jack Bairstow and Mr. Wayland Cedarquist, a member of the joint committee which drafted the amendment, debated its merits in spirited but friendly disagreement. Our president takes a brief look ahead:

Mrs. McPherson Holt has accepted the chairmanship for Local CA 1)"A study of county government with special reference to the townships in which Lake Forest is located, and alternative forms of county government," The state legislature is showing a revived interest in county government. Last year the office of township collector in Lake County was discontinued by popular referendum; and people generally are becoming aware of the present cumbersome and inefficient government of our counties. The League can perform a real aublic service by a thorough study of the existing structure, and perhaps be able to suggest alternatives found more efficient in other states.

Mrs. George B. Rogers will be the chairman for Local CA 2) "A study of the home rule powers granted to the city of Lake Forest by its charter, with possible appropriate action." This study will cover the differences between operation under our special charter and operation under the Cities and Villages Act which permits a municipality to choose one of three forms of government. If at any future time the legislature should abolish all special city charters, the League would be prepared to inform Lake Foresters on the merits of these three alternatives, so that a wise choice could be made. (It is possible that the design to abolish special charter school administrations - see above under Local CRs - was a sort of trial balloon on polishment of special city charters as such.) Of course, one part of the study would be the city's relation to its school districts.

At the state convention in May, three Current Agenda items were adopted. The first, really a continuance of the League's long effort towards passage of judicial amendment, provides that the League will do its utmost to arouse public support for this long over-due reform. Mrs. Gordon J. Bina is chairman of this item for our local League.

Mrs. Frederick W. Toohey is chairman for the second state CA item: "Improvement of the election laws and procedures." Chairman of the third CA item - "Evaluation of public school finance" - is Mrs. Strabo Claggett. While both of these items are new on the Illinois CA, they represent long-time League interest and concern. And the study of public school finance should provide a sharp new tool for work on a future Revenue Amendment.

Now my very personal thanks to all Board members for their faithful and conscientious work through the year, and for their generous patience with a new and inexperienced president. So another year begins - good luck to all of you!

TWO ITEMS RECOMMENDED FOR '58-'60 NATIONAL CURRENT AGENDA

At the general meeting on November 4, Lake Forest League members agreed to recommend the following agenda items to the National Board for its next two year program: (agreement was reached on general content; wording of the items will be worked out by a committee headed by Mrs. Robert E. Spiel)

- I. Conservation: support of a federal water policy based on adequate data and more efficient administration.
- II. A study of the cultural, political, and economic patterns of the Middle East, in search of a more effective U.S. foreign policy.

It was agreed that if the present Individual Liberties item qualifies (i. e. if the League as a whole reaches a position), it should be added to the National Continuing Responsibilities; and that CR #8 (Measures to counteract inflation or deflation) should be removed from the list.

Other CA items proposed were:

a) A study of the St. Lawrence Seaway and the economic and social effects on the areas served by it.

b) A study of U.S. communications with the rest of the world through various media.

BOARD STUDIES POSSIBILITIES OF UNIT ORGANIZATION

At its last meeting, your Board discussed the possibility of reorganizing the Lake Forest League on the Unit Plan. Realizing the need of careful study of the pros and cons of unit organization as it would or would not meet the needs of our League, the Board asked Mrs. Brown to appoint a committee for this purpose. Mrs. Willard N. Boyden will serve as chairman, assisted by Mrs. Walther Buchen, Mrs. A. D. Eastman, and Miss Julia Mae Hamilton.

All discussion at this point is purely exploratory. Mrs. Brown has asked Mrs. Clarence Goelzer, past chairman of the Ill. LWV Organization Committee, to speak to the Board at its December meeting on the Mechanics of Unit Organization, and to answer our questions. Anyone who has any comment to make either for or against unit organization is requested to get in touch with a member of the above committee before the next Board meeting on December 9.

WHAT LOCAL TOPICS SHOULD OUR LEAGUE STUDY NEXT YEAR?

LAKE FOREST REPRESENTED ON ILL. LWV BUDGET COMMITTEE

Each year the Budget Committee of the Illinois LWV is made up of representatives from half of the local Leagues in the state. This year the Lake Forest League is among those to be so represented. Mrs. Charles H. Brown has been appointed to serve in this capacity.

WHERE DOES THE MONEY COME FROM TO FINANCE OUR PUBLIC SCHOOLS?

As pointed out in the November-December issue of The Illinois Voter, local property taxes meet, on the average, about 80% of the cost of our public schools in Illinois. In the more prosperous districts local taxes may provide as much as 95% school revenue. State aid averages about of school budgets, and comes from the General Fund which is fed chiefly by sales and use taxes.

Only about 1 1/2% of public school revouces. While Illinois schools have many unmet and growing needs, our state is better able to bear the financial burden than some others, particularly in the south. Every year Congress is pressed to provide more federal aid for the nation's schools; but the lawmakers reflect the fear of many of their constituents that federal aid will lead to federal control of educational policies.

SECOND ROUND OF PROGRAM MAKING

At the March general meeting the proposed national Current Agenda was discussed. (See National Voter. February, 1958). League members felt that the first item on international relations was too broad, although they were not ready to suggest an alternative wording. They recommended that the National Board be asked to interpret the item and plan material so that one geographic area and all aspects of U.S. foreign policy relating to it could be studied the first year; and that each League be permitted to choose the area it prefers to study. In the second year this study could be related to the whole field of U.S. foreign policy,

In discussing the second proposed item, Miss Hamilton reported that her committee on conservation felt that the words "optimum development" might have unfortunate connotations, such as stress on electric power rather than on basic conservation. The committee, also wanted the item to show that the best use of our precious resource, water, depends upon sound conservation practices. The suggested wording is, therefore, "Conservation: promotion of the best possible use of water resources consistent with river basin needs and sound conservation practices."

FOREST PRESERVE

Illinois statute provides that a forest preserve district may be established by a majority vote in popular referendum. The general provisions pertaining to the projected Lake County preserve are:

The County Board of Supervisors shall have complete jurisdiction as to what tracts of land shall comprise the preserve. These tracts need not necessarily be contiguous, but each must contain one or more natural forests and may include other land, such as marshlands, waterways, fields, etc.

The County Board may condemn land for the preserve and it also must levy a tax for the development and maintenance of the preserve, not to exceed .025% of assessed valuation.

SERVICE TO THE COMMUNITY

Voters Service

The Voters Service committee wrote articles for the Lake Forester and the Waukegan News-Sun which pointed up the need for judicial form and for a new judicial district encompassing only Lake County: reported interviews with the 6 judicial candidates; included an editorial emphasizing the importance of the primaries.

Mrs. Walther Buchen, chairman, and members of her committee participated in the November naturalization ceremonies in Waukegan, where they welcomed the new citizens and assisted them in registering.

A lively general meeting in April included discussion of the political party at the county level, the primaries and the endorsement of write-in candidates.

A new issue of FACTS FOR LAKE FORESTERS will be printed next fall. This spring Mrs. John Nagel and her committee have successfully lined up the supporting advertisers. The League appreciates the cooperation of these business firms.

SERVICE TO MEMBERS

Membership Social Activities

The membership committee, headed by Mrs. David P. Cordray and her co-chairman, Mrs. Herbert P. McLaughlin, has had another successful year. 26 new members have been introduced to the League, bringing the total membership to 224. The "Bring your sandwich" luncheon plan has been continued and expanded. These luncheons preceding many of the regular monthly meetings, have helped new members feel at home in the League; have encouraged their participation in League activities; and have been a means of introducing new and prospective members to the regular League members.

The teas after the general meetings and the scheduled luncheon meetings were arranged by Mrs. John W. Suter, Jr., assisted by a team of League hostesses.

Three orientation meetings, conducted by Mrs. Granger Brown, were held for new members. She discussed the purpose and organization of the League, outlining the structure and development of its program.

A postal card poll of the membership indicates great interest in the areas of International Relations and Conservation. I. County Government

A committee of 12 members of the League, with co-chairmen Mrs. McPherson Holt and Mrs. John C. Christie, met in two workshops to hear Dr. Richard W. Hantke of Lake Forest College discuss the historical background of county government, its structure and functions. Members of the committee presented written reports on different aspects of county government. A resume of his talks was given by Dr. Hantke at the January general meeting. At this time Mr. Frank B. Peers, County Supervisor from Highland Park, also spoke, giving details of the actual work of the Lake County Board of Supervisors, its problems and future plans.

II. A study of the home rule powers granted to the City of Lake Forest by its charter, with possible appropriate action.

Mrs. George B. Rogers, chairman of the committee studying this item, conducted two workshops where ten members participated in the discussion. At the October general meeting Mayor Morrison Waud was introduced to the membership and gave an interesting talk on the specific advantages of Lake Forest's special charter.

STATE AGENDA ITEMS

Judicial Amendment

During May and June 1957, the Citizens Committee for the Judicial Amendment maintained a flow of information on the progress in the Legislature of the Joint Bar Associations' proposal (SR-17) for judicial reform, Leagues were asked to contact the Governor and legislators to urge its adoption.

However, on June 27, the Legislature finally passed SJR-47, a proposal introduced by a legislative committee of both Houses. This amendment will be on the Blue Ballot in November. The selection and tenure of judges is the outstanding departure of the Legislature's proposal from the Bar Associations' original draft.

The State Board postponed a statemen of the League's position on SJR-47 to allow time for study of its provisions. In September the governing bodies of both Bar Associations voted to support the proposed article. In October the State Board asked for an expression of opinion from local Leagues. Mrs. Gordon J. Bina, Chairman of the Judicial Committee, reported to our Board at its November meeting that the consensus of her committee was to support SJR-47. After discussion, the Board also voted, unanimously, to recommend support to the State League. Notice to this effect was sent to Mrs. James A. Velde, State Judicial Chairman. On November 15 the State Board decided, unanimously, to support the proposed Judicial Article.

II. Election Laws and Procedures

In three intense workshops, Mrs. Frederick Toohey, her co-chairman Mrs. George B. Rogers, and their committee, discussed absentee voting, permanent registration, poll officials, new parties, primaries and the short ballot. Judge Otto Kerner of the Gook County Court spoke to the June membership meeting on Election Laws, pointing out the need for constitutional and legislative changes.

III. Public School Finance

With four workshops and a program at the February general meeting, Mrs. Strabo Claggett and a large committee dug into an "Evaluation of Public School Finance" in Lake Forest, feeling that an understanding of local problems would provide a sound basis for interpreting state problems, and recognizing that property taxes pay about 80% of the cost of the schools. A need for amendment in the general property tax was noted. The four tax assessors were interviewed and a panel meeting planned for February. The program was well-organized and each individ ual talk of real interest. The League members appreciated the cooperation of the tax assessors and the frankness with which each man spoke.

LEAGUE LINES

NATIONAL AGENDA ITEMS

Evaluation of the Federal Loyalty-Security Programs

Under the direction of Mrs. Norman Anderson, chairman, this item was studied by a committee of ten during the spring of 1957 (reported in last year's Annual Issue of the Bulletin). This culminated in a general membership discussion at last November's meeting. At this time our League membership recommended to the National Board that this item be put on Continuing Responsibilities.

II. Conservation: A Study of Water Resources

Three workshops were held in October and the committee's study was divided into three parts: the financial and physical aspects of the water problem; organizational problems; and the water study commissions appointed by three different Presidents. State meetings were attended by members of the League committee. At the November general meeting, Miss Julia Mae Hamilton, chairman, presented a proposal for a new National item on Conservation. This item which the membership voted to recommend to the National Board was very similar to the item finally adopted by the National Convention. (See May Bulletin.)

At the December meeting, to which the members of the Lake Forest Carden Club were invited, Dr. Ira Gabrielson spoke on the need for an adequate federal water policy.

STATE CONTINUING RESPONSIBILITIES

Mrs. George Reilly met with her committee in June to assign items to be followed throughout the year. In October Mrs. Walter Fisher, a past president of the State League gave a summary of the Continuing Responsibility items. This proved an excellent means of introducing new members to the activities and interests, past and present, of the League.

NATIONAL CONTINUING RESPONSIBILITIES

In the fall the International Relations committee under the direction of Mrs. William Frost, chairman, and Mrs. Robert Wilson, co-chairman, met twice to review Continuing Responsibilities 1-5 and to discuss possible subjects for the National Agenda.

The committee recommended a study of the Middle East for a National Agenda item, and presented ite proposal at the November general meeting where it was accepted as the Lake Forest League's recommendation to the National Board. (See May Bulletin for details on the international item finally adopted by the National Convention.)

In February and March a series of group discussions was scheduled based on the Great Decisions program of the Chicago Council on Foreign Relations. Both morning and evening meetings were held for members and guests. Mr. Livingston Fairbank was moderator for the evening group while Mrs. Reilly and Mrs. Burns conducted the morning sessions.

The League was fortunate to have Dr. Robert G. Andrus who had just returned from a trip to Egypt, speak to us on the Middle East at the March general meeting at Ferry Hall.

The role of a local league president is both more specific and more general than that of any other board member. On the specific side, she has to carry out board decisions on policy and she has to see to it that all league functions (both program and administration) are fulfilled; on the general side she must, to the best of her ability, keep the League's purpose clear to its members and to its community. The League's purpose is the reason for its existence.

A local league's response to "calls for action" is really the synthesis of all its work and it is quite difficult to determine how successful a given response has been. Since the various chairmen will be reporting their particular activities, this report will attempt to cover only the Lake Forest League's answer to "calls for action" from April 1957 to April 1958.

In April 1957 there were two state "calls for action": support for SJR 17, the Judicial Amendment, and SR 129, creating an equality of Employment Opportunity Commission. For the first call the League was well prepared. We had held several workshops and recently at a general membership meeting had heard Rep. Bairstow and Mr. Wayland Cedarquist debate the proposal: action cards were mailed to all members urging letters to Sen. Arrington and to Rep. Bairstow. (A later call on this same measure in May was discussed at a general meeting and all members were urged to use whatever pressure they could devise. Telegrams also went to Senators Arrington and McClory,) For the second call -- Equality of Employment Opportunity -- our league was not well prepared. We had done no work during the previous year on the State CRs and work done even before that time had been nullified by the membership turnover. As the "call" required immediate action there was no time for even hurried preparation. However, all board members were telephoned and asked

to write or talk with Sen. McClo twenty members who had known measure in the past were also telephoned.

In May 1957 there were two "calls for action" from the national office on Foreign Economic Aid. Action cards went to all members; the board was particularly urged to act; and the matter was also discussed at the June general meeting. In August there were also two additional "calls" on this same matter. Telegrams went to both our senators and all board members as well as some regular members see were eached by telephone if they were in town. Our telegram to Mrs. Church on the second "call" (though sent immediately) reached her after the vote had been taken in the House.

In 1958 to date, two "calls for action" have come from the national office. The first asked for opposition to SR 1411, a bill whose original sensible content had been completely amended in the House to extend the lovalty-security programs to cover all government employees. The League favors narrowing such coverage to sensitive positions, only. This "call" was discussed at the March and April general meetings; an explanation appeared in the March Bulletin; and personal letters went to Mrs. Church, Senators Dirksen and Douglas, as well as an official letter to each of these from the president for the League.

In the March bulletin there was also an explanation of the "call for action" on renewal of the Trade Agreements Act. This call was discussed at the April general (annual) meeting and at the final Great Decisions discussion meeting. Letters from the League went to both our senators and to Mrs. Church from the president for the league and a statement of the league's position, with reasons therefor, was published in the Lake Forester.



Spring is the time for new hopes and new plans. A new president and a new board are assuming direction of league affairs. All the best wishes of the old president and the old board go out to them. Good luck!

LAKE FOREST LEAGUE ORGANIZATION

BUT DEAD

A committee of the Board met during the summer to consider the organization of the Lake Forest League in order to distribute the work on the program and to increase member participation. At its September meeting the Board voted to accept the recommendation of this committee: that each month throughout the League year be devoted to emphasis on one particular program item, both at the general meeting and in the workshops; that evening meetings be included whenever feasible.

The following calendar was adopted: October - Judicial Amendment November - Voters Service December - Proposals for State Agenda

TRADE AGREEMENT ACT

There were two "Times for Action" calls to the League in July on the Trade Agreement Act. The bill was passed August 11th with a four year extension, the longest granted in the 24 year history of the Act. However, for the first time, the Act gives congress a measure of control over the President's tariff-cutting decisions. A twothirds vote of both houses can overrule those decisions which do not agree with the Tariff Commissions recommendations in "escape clause" cases.

The N. Y. Times (June 12) lists the L. W. V. as one of the groups responsible for the pro-extension sentiment which was demonstrated convincingly to Ongress.

JUDICIAL AMENDMENT COMMITTEE

The committee for the Judicial Amendment participated in two activities during the summer, one sharing the Lake County Leagues' booth at the County Fair, the other cooperating with the Lake Forest Citizens' Committee for Modern Courts.

Five Leagues worked together at the Fair, July 24, 25, 26 and 27, preparing the booth and supplying workers. League members were assisted by members of the Lake County Bar Association in answering questions, distributing literature and conducting a contest. Visitors to the booth were asked to guess how many organizations in the State are supporting the Judicial Amendment. The correct number is 5,177. Lake Forest League members, contributing prizes and hours of work were Miss Hamilton, Mrs. Gilboy, Mrs. Roberts, Mrs. Rooney, Mrs. Spiel, Mrs. Theodore Wilson, and Mrs. Boyden, League chairman of the judicial item.

The Lake Forest Citizens' Committee for Modern Courts, under the chairmanship of Mr. Michael Gilboy, held meetings on June 23 and July 14, which were attended by many League members. Other officers of the committee are Mrs. Roberts, Mrs. Leo Porett, and Mrs. Boyden. The committee is planning an extensive educational campaign for the month of October during which there will be a meeting open to the public where a film will be shown and questions answered. This film will be available without charge to groups in the community. It is hoped that many

League members will be interested in borrowing the slide film and disseminating information to help educate voters to support the Judicial Amendment at the polls on November 4.

UNITED NATIONS DAY: OCTOBER 24

At the National Convention last April,
the L. W. V. voted overwhelmingly for a
Foreign Policy item which should include
"Evaluation of U. S. foreign policy and
continued support of the United Nations
system." Such an examination can give
League members a basis for detailed
study and eventual action.

With annual United Nations Day approaching, League members are reminded that there are at least three ways at hand whereby League members can find information to broaden their knowledge of the United Nations.

- Newspapers: The daily N.Y. Times carries the full text of communiques and important speeches at U.N. sessions.
- 2 Libraries: The Lake Forest Library has much pertinent material available.
- 3 Radio: Programs are broadcast from the United Nations during crisis period and many programs such as "Meet the Press," "Face the Nation," help to clarify current issues.

STATE CURRENT AGENDA, 1959-61

At the December membership meeting of the Lake Forest League, a program devoted to working for a Constitutional Convention for Illinois was selected as the item to be recommended to the state board for its 1959-61 program.

The consensus of the meeting was that the League would prefer to work on this one big project only, but considerable continuing interest was indicated in judicial reform and in evaluation of financing of public schools.

A committee, consisting of Mrs. Granger Brown, Mrs. Robert Spiel, Mrs. F. P. Hixon and Miss Julia Mae Hamilton, was selected to develop a statement based on the discussion at the membership meeting. This committee has recommended that the following proposals be sent from the Lake Forest League to the State Board, with the explanation that this League would prefer to see the first item adopted alone, but that the League membership continues to be interested in the second two items:

- To work for a Constitutional Convention for Illinois.
- An analysis of the services required of local, state, and federal governments as related to the tax structure, with special attention to the problems of public school finance.
- Improvement of election laws and procedures with special emphasis on required instruction for judges, shorter hours for judges and consolidation of election dates.

INFORMATION TO VOTERS: SCHOOL REFERENDUM

The Lake Forest League of Women Voters has long been concerned with good public education in Lake Forest and is currently studying Public School Finance in Illinois. The following information is of particular interest.

The Lake Forest Public School Elementary Board has called for a referendum on Saturday, February 14, 1959, to increase the present school tax limits. There are three funds currently under consideration in Lake Forest: Educational, Building Maintenance and Transportation. To gain an understanding of this referendum it is necessary to view comparatively first the local and the state tax limitations, and secondly the 1957 and the estimated 1958 local tax rates, as well as the extension of tax limitations recommended by the Elementary School Board.

By law the educational fund of an elementary school district may have a rate without referendum of \$.65 on each hundred dollars of equalized assessed valuation; and by referendum may raise the rate limit to \$1.40, the amount of increase in rate being not more than 21f at a single referendum.

As "League Lines" goes to press the Lake Forest L. W. V. has taken no stand on this referendum. The League is studying the proposal under the direction of Mrs. Graham Ely and it will be further discussed at the February 2nd, general membership meeting.

BOUQUETS TO THE LEAGUE

The February 17th issue of LOOK magazine, page 77, anouncing the "All America Cities" awards, reads like this: "Progress in municipal government is principally due to two factors, according to Richard S. Childs, originator of the council-manager form of government and chairman of the executive committee of the National Municipal League. He credits the spread of effective Leagues of Women Voters and of the council-manager plan. Both have doubled in numbers in ten years."

PROPOSED CHANGE IN BY-LAWS

It has been recommended by the Board of Directors of the League of Women Voters of Lake Forest that the local by-laws be amended to read as follows:

(changes are underlined)

ARTICLE II section 2

The League of Women voters of Lake Forest may take action on local government measures and policies in the public interest in conformity with the Principles of the League of Women Voters of the United States. It shall not support or oppose any political party or candidate.

ARTICLE V section 1

The officers of the League of Women Voters of Lake Forest shall be a President, two Vice-Presidents, Recording Secretary, Corresponding Secretary, and Treasurer. The President, one Vice-President, and the Recording Secretary shall be elected in odd numbered years, and the other Vice-President, Corresponding Secretary, and Treasurer in even numbered years. Their term of office shall be two years. Officers shall be elected by voting members at the Annual Meeting and take office immediately.

ARTICLE V section 2 b

The senior Vice-President shall in the event of absence, disability or death of the President, possess all the powers and perform all the duties of that office, until such time as the Board of Directors shall elect one of its members to fill the vacancy. The Vice-Presidents shall perform such other duties as the President and the Board may designate.

ARTICLE VI section 4

Budget Committee. A Budget Committee shall be appointed by the Board of Directors at least two months prior to the Annual Meeting to prepare a budget for the ensuing year. The proposed budget shall be sent to all members at least two weeks before the Annual Meeting. The treasurer shall not be eligible to serve as chairman of the Budget Committee but shall act as a member ex-officio.

ARTICLE IX section 2 d

Recommendations for Current Agenda submitted by voting members two months prior to the Annual Meeting but not recommended by the Board of Directors may be considered by the Annual Meeting provided that: (1) the Annual Meeting shall order consideration by a <u>Majority</u> vote and (2) the Annual Meeting shall adopt the item by a two-thirds vote.

It was mailed to all Lake Forest telephone numbers listed in the directory (2,875 copies), all members of the League, doctors' offices, advertisers (111 copies) and 14 organizations and groups who requested in all 197 copies. Later, 150 additional copies were sent to non-advertisers and delinquent advertisers.

The task of publishing "Facts" is broad and demanding. (Advertising, mailing, proofreading, "information-getting"). Mrs. Robert O. Lehmann, Chairman, and her Co-Chairman, Mrs. Martin G. Pesek, were assisted by Mesdames Chainski, Dilg, Beidler, Burns, Fromberg, Christie, Jacques, Lydy, Reilly, Speil, R. Q. White, Pellet, Miller, and Misses Brown and Hamilton. Congratulations to all!

NATIONAL AGENDA ITEMS

I. Evaluation of U. S. Foreign Policy with Continued Support of the United Nations System, World Trade and Economic Development, and Collective Security.

At the annual meeting Mr. Irving Pflaum, Foreign Editor of the Chicago Sun-Times and Professor of Journalism at Northwestern University, spoke on the subject, "Has U.S. Foreign Policy Failed". This provocative talk stimulated much research in preparation for the workshops which followed.

Under the Co-Chairmanship of Mrs. Strabo Claggett and Mrs. William Frost, and with the assistance of Mrs. Granger Brown, three well-attended workshops were held in April. Their objective was to gain a general perspective on our foreign policy as it is related in specific areas of conflict to that of Russia.

The first workshop reviewed the history of American diplomacy during the last 50 years. George Kennan's "American Foreign Policy from 1900 to 1950" was used as background. A report was made on Red China and the workshop concluded with a review of the situation in the Middle East. The second workshop concentrated on the European Common Market, Nato, and the Red Satellites. The final meeting opened with a discussion of the Berlin Crisis and the proposed Summit meeting, and concluded with a general discussion of a more effective Foreign Policy.

The culmination of this month of study was a League-sponsored talk by the Hon. Marguerite Stitt Church who spoke at Ferry Hall on May 10th on "The Realities of American Foreign Policy". The entire community was invited and responded enthusiastically to this challenging and inspiring talk.

II. Water Resources: Support of those National Water Policies and Practices which Promote Coordinated Administration, Equitable Financing and Regional or River Basin Planning.

Under the direction of Mrs. Richard Bentley, Chairman, this item was studied by a committee of 10 during the month of January. The emphasis of the study was on the Great Lakes St. Lawrence basin, its part in our national water problem.

Papers were presented by League members at three well-attended workshops on different phases of this subject. "Who pays for it and why?" "How do we protect our natural resources in the Great Lakes area?" "What part does the U.S. Fish and Wildlife Survey play?" "What is the Great Lakes Commission" "What about shore erosion?" "Pros and cons of diverting water from the Great Lakes."

At the general meeting Colonel John T. O'Neill, Engineer Fifth U. S. Army, spoke on the function of Federal agencies, especially that of the Army Engineer Corps, in the development of the St. Lawrence Seaway.

Further study in our 1959-60 League program is planned with especial attention to be given to the cost-benefit area.

FINANCE REPORT

Once again the Finance Drive has met with outstanding success. Mrs. Lawrence A. Carton Chairman, reports that 81 non-members and 98 members contributed \$2,033.00. Congratulations to her and to her committee!

STATE AGENDA ITEMS

Promote citizen responsibility for court reorganization and nonpartisan selection of the judiciary.

All League members are acquainted with the effective job accomplished by the committee, under the Chairmanship of Mrs. Willard Boyden, which directed the total effort of the Lake Forest League ward the end of passing the Blue Ballot Judicial Amendment last November. Despite the fact that it did not carry in the state, 85% of those who voted on this amendment in the 10 precincts of Lake Forest. Lake Bluff and Deerfield voted for it.

Cooperation was the keynote of the many weeks of work which preceded Election Day. The efforts of this committee were pooled with those of Voters Service, Mrs. Howard Roberts, Chairman, A local Citizens Committee was organized. (50% of its members were L. W. V. members). Lake Forest and Lake Bluff worked together in conjunction with this committee. Members of the Lake County Bar Association worked at the County Fair. Both the Lake Forester and radio station WKRS, Waukegan, were cooperative in giving space and time. The League board became a telephone directory to alert subscribers to a meeting of the Citizen's Committee. This type of community effort, spearheaded by the planning, organization and goals of the L. W. V. will remain an inspiration.

II. Evaluation of Public School Finance

The second year of this League study was devoted to an analysis of the theories and realities involved in the coordination of state and local financing of public schools. Mrs. Graham B. Ely, Chairman, and Mrs. Charles Brief outlines of the most timely of the Con-Dabney, Co-Chairman, worked with a small but interested committee studying material supplied by both the League and the State (School Problems Commission Reports). Much consideration was given to analyzing this in relation to the

local school finance and assessment situation. Dr. John Springman, Superintendent of the Glenview Public Schools, addressed a wellattended workshop.

The study of this committee led to the inevitable conclusion that further study of possible additional sources of state revenue was needed.

III. Improvement of election laws and procedures.

The month of March was devoted to the study of the election laws of the state with special attention being given to absentee voting, education of judges, consolidation of election dates, permanent registration and the short ballot, Mrs. Arthur C. Rooney, Chairman, introduced as speakers at the general membership meeting Senator Robert McClory, and Representative Jack Bairstow. There were three well-attended workshops led by Mrs. Rooney and her Co-Chairman, Mrs. Robert Stuart, Jr. At the first, Mr. Deneen Watson spoke, giving a practical background to the more theoretical League study; at the second, States Attorney Robert Tieken gave a detailed and challenging account of some of the actual abuses of the election laws which have occurred in city elections; at the third, reports by League members were given on precinct size, the history of registration and election dates. Mrs. Frank Hixon spoke on the part the L. W. V. had played in achieving "Permanent Registration".

STATE CONTINUING RESPONSIBILITIES

The subject of the December general meeting was "How We Make Program", under the Chairmanship of Mrs. George Reilly. tinuing Responsibility items were given by members. Tally sheets were used to prepare a summary of membership interest in order to make suggestions for next year's State Agenda.

LOCAL AGENDA ITEMS

 Study of the official city plan with special attention to conservation and beautification in business areas with possible appropriate action.

The subject of this study has been in the local headlines many times during the year. Mrs. Samuel Taylor and her committee have actively alerted the community to this problem. They participated in forming a Gitizens Committee; they regularly attended City Council meetings and Public Hearings; they helped to formulate the resolution presented to the City Council requesting a change in the city ordinance; and they met with the Chamber of Commerce in order to secure its cooperation.

There was real public relations value derived from this work. The League initiated the program and brought it to the attention of many people, arousing their interest. Merchants have already planted in front of their stores. At the time the committee Chairman's annual report was submitted a thorough groundwork had been laid and there seemed to be a "reasonable chance of success".

II. Continued study of County Government with emphasis on planning and coordinated action where indicated.

At the February general meeting two women precinct committeemen, a Republican and a Democrat, spoke about the responsibilities of their office, and gave the background of their own elections. Mr. E. Kenny Harlan, assistant township supervisor, and a member of the County Board of Supervisors, described the organization and function of this Board.

Three workshops were planned by Co-Chairmen Mrs. McPherson Holt and Mrs. Botsford Young. At the first, a digest of the reports of the previous year was discussed, at the second Dr. Arthur G. Baker, County Health Director, and Mr. S. Grosshandler, Chairman of the Lake County Regional Planning Commission, outlined their present responsibilities and spoke

generally as to their planned goals; at the third, Mr. R. C. Morris, County Planning Commission and Mr. R. G. Jasper, Supervisor of Assessments spoke.

League members at these workshops were impressed and inspired by the sincere and intelligent dedication of these speakers to the public services which each represented and to the general cause of county planning.

Under this item, the Lake Forest League worked for a County Forest Preserve (see President's report).

COMMUNICATION

The Lake Forester has allotted generous space to the excellent reports, both regular and special, of the Chairman of Publicity, Mrs. Richard Templeton, throughout the year.

Public Relations cannot be measured in terms of days or agenda items. It is importa at all times and in all phases of League work. The job accomplished by Mrs. Solomon B. Smith and her committee has been effective throughout the year. Their ability to keep close to city government, to attend council meetings, and public hearings has been of special value.

The bulletin, "League Lines", provides a regular means of communication with the entire membership. It is a monthly calendar of League meetings and workshops. It alerts the membership to those local, state and national matters which are of particular League concern.

THE PRESIDENT'S REPORT

The Lake Forest League of Women oters has had an active year in its work "to promote political responsibility through informed and active participation of citizens in government".

Two of the program items of this past year serve to illustrate the League's work toward its goal. The first was the state item on the Judicial Amendment. The Judicial Amendment Chairman, the Voters Service Chairman, and their respective committees did a valiant educational service, not only to the members of the League, but to the community on the need for judicial reform and the importance of going to the polls to vote. Talks were made and a film was shown to most of the community organizations; there were radio programs; there was a booth at the County Fair. In cooperation with a Citizens Committee a public meeting was held. There were many League members at the railway stations and at the polls with flyers. Though the Amendment failed to carry in the state, it passed in Lake Forest with a large majority.

The second illustration was the work done on the proposed Lake County Forest Preserve. The many League members who gave invaluable service in organization, education, and voters service contributed to the success of this venture.

There has been a new system of program planning this year - - that of dedicating one month to one program item both for general membership meetings and workshops. This plan was evaluated at the June Board meeting and will be tried for another year. The advantages of a period of concentration on one subject are obvious, but it was recognized that inherent in such a plan are tendencies toward rigidity which must be avoided.

No report however brief could be given by this president without an expression of deepest appreciation of the excellence of the work done by the Board members, their Co-Chairmen and committee members. It has been a privilege to work with them. I want to take this opportunity to thank the many

members who have enhanced the work of the year by means of their gracious hospitality in their homes and as hostesses at the membership meetings.


"NATIONAL SECURITY COUNCIL" TO FOCUS ON FOREIGN ECONOMIC AID PROGRAMS

At the mock "National Security Council" meeting, Monday, October 5th, the League will conduct a study-in-depth of the problems attending the U. S. foreign aid programs. Last May, when the National Council of the League of Women Voters met, it was decided to make the second year's study, under the foreign policy program item, a focus on problems of economic and technical assistance. According to the National Board Report this decision was taken for very practical reasons related to action: "it was recognized that a combination of economic and political circumstances make the coming year a crucial time for economic development. . . .; the need for sound policies is more urgent than ever before, with the swift emergence of newly independent nations, the mounting 'revolution of rising expectations' and the launching of an economic offensive by the Communist countries. . .; the League with its recent study on the objectives of foreign policy. . . is in a strategic position to help evaluate present and proposed programs."

Some of the problems to be exposed are, for example, what kind of aid should be given a certain country? Should it be tagged for basic industrial development or for social overhead? Should it have "stringe" attached? Do we expect economic or political results? What priority for military aid? And finally, what programs will best serve the interests of the United States? Granting that Russia's ultimate objective is work domination, what is her present strategic objective -- Europe, the Middle East, Africa?

The National Board Report rolls all these questions (and a few more implied) into one:
"What would be the essential elements of a really adequate, effective, coordinated total program of development assistance: its scope, size, organization, national and international components, mechanisms for coordination of individual programs?" And your Foreign Policy Committee suggests that we must face also the question of recognition of Red China and her admission to the United Nations (then what of Formosa?) and our policy toward both France and Algeria in their present unhappy impasse, in fact, our whole attitude toward colonialism which must include Africa and the Middle East and India. **

National Item II: WATER RESOURCES: SUPPORT OF THOSE NATIONAL WATER POLICIES AND PRACTICES WHICH PROMOTE COORDINATED ADMINISTRATION, EQUITABLE FINANCING AND REGIONAL OR RIVER BASIN PLANNING.

Water Resource Development: November 1959, L.F.L.W.V.

After four years of water resource study the League approaches the "Action stage". Water political and lake diversion have spread even to North Shore suburbs. We begin to see how our Lake County problems merge with those of metropolitan Chicago.

At the regular membership meeting November 2, Mr. C. J. Mclean, chief hydraulic engineer, Commonwealth Edison Company, and a member of the advisory board of Northeastern Illinois Metropolitan Area Planning Commission, will speak. This commission was created by the state legislature two years ago and is presently negotiating with the Ford Foundation for grants for studies of water supply problems and flood control problems in the Chicago metropolitan area. This meeting will be followed by three workshops, November 5, 12, and 19 (see Page 1 of this Bulletin), when some of the many bills which are scheduled to come before Congress in 1959-60 will be discussed. There are old friends in new form as well as brand new bills. It is heartening to note that Water Pollution Bill, HR 3610, was passed by the House June 9 and will continue its legislative course next session.

The National Board of the L. W. V. believes appropriate League action may start with the Senate Select National Resource Committee, whose stated purpose is to make a broad scale study of water resources and water policies as they affect population, agriculture and industry in an attempt to establish the water needs of the country by 1980. Its study will encompass weather control, desalinization of brackin water and the application of nuclear energy. National Board members may approach members of this committee to explain League interest in administration, regional planning and equitable financing and to recommend that the study include a search for solutions to these complex administrative problems. National Board members and League state representative have greater chance of success in this Senate committee if there is increased citizen interest in water.

This can be the beginning of a long-time campaign to get League findings incorporated into law and effective administrative operating toward those needed changes which could result in a national water policy.

CONSENSUS ON FOREIGN POLICY STUDY

IN RESPONSE TO a query from the National Board, the answer to which would guide the League's action in the forthcoming session of the Congress, the Lake Forest League answers the following questions:

(1) Do we want to continue to work for "long-rangeness" in the DLF and in other programs where this element can be introduced?

We would support a flexible policy which makes possible a long range approach. Our belief is, to quote Mr. Paul Nitze in Annex A to the Draper Report, March '59, "a basic objective of U. S. foreign policy is the creation and maintenance of a system of world order within which U. S. interests and U. S. security can find their satisfaction."

(2) Do we want to continue to press for expanded economic aid? Do we want to increase lending resources by continuing to support, for example, larger sums for the DLF? Would we be willing to participate with other developed countries in a larger aid effort?

We would support maximum economic foreign aid consistent with a sound U. S. fiscal policy which, among other factors, takes into account the present gap in balance-of-payments and its possible continuance. We deplore the new DLF policy of tying loans to exports as inconsistent with the stated purpose of DLF and inconsistent also with the long-time League policy of freer trade. We prefer loans to grants wherever possible and we would wish for measures to encourage the utmost use of private investment in foreign economic development.

(3) Do we want to work for greater contributions to international instruments for commic aid? Do we want to support new international lending agencies, like the International Development Association, through which the major part of our economic aid could be channelled? If so, should we continue to work for increased funds for DLF?

To parts (1) and (2) the answer is "Yes". In answer to part (3) we feel we should support more effective application of funds for DLF rather than increased amounts but we recognize that in some cases increased amounts may be necessary.

(4) Do we want to work for greater coordination of U. S. programs by supporting a single U. S. administering agency, either under the Dept. of State or separate from it? Should we place increased emphasis on improved procedures for the selection and training of U. S. representatives abroad?

To the first -- we would certainly support greater coordination and cooperation among existing foreign aid programs. We have not studied the "single agency" proposal for administration of all foreign aid programs and so cannot answer the question specifically, the second -- of course, we approve "improved procedures for the selection and training of U. S. representatives abroad" but we feel this subject is not included in our present CA item and therefore should appear as a new CA item if the League desires to take a position upon it.
