LOCAL:

1. Continued attention to youth problems, including recreational needs and a service directory which is already published with Lake Bluff.
2. Continued attention to the needs of young children including our pre-school booklet and support of pre-school programs and recreation programs.
3. Support of the 1978 Comprehensive Plan for Lake Forest
4. Continued study of the need for additional pet regulations, i.e. leash laws.
5. Continued attention to the Lake Forest Caucus system.
6. Update of the Lake Forest Portrait.
7. Update study on gun control.
8. Study the advisability of an elected school board for the City of Lake Forest District 67.
9. Study the existing Lake Bluff recycling program and its proposed expansion.
10. Continue Lake Bluff Shoreline study.
11. Continue Lake Bluff Real Estate Tax study.

COUNTY:

1. Study of the future use of Fort Sheridan.
2. Task force to study the need, funding and delivery of services for youth in Lake County.
3. Study of the transportation needs of Lake County.
4. Lake County Jail Task Force.
5. Hazardous Waste Task Force.
6. Solid Waste Task Force.
7. Support Positions on Watershed Management (1975); Land Use in Lake County (1977, revised 1986 & 1988); Solid Waste Disposal in Lake County (1981); Forest Preserve District of Lake County (1988); Lake County Government (1988 & 1989).

STATE:

1. Support of improved services of Illinois state agencies serving children and their families.
2. Support for League positions to implement, amend and uphold the 1970 Illinois Constitution.
3. Support of improved criminal justice procedures in Illinois, alternatives to incarceration and gun control.
4. Support of improved election laws and procedures.
5. Support for a state land use policy that addresses the problem of conflicting uses for the land resources of Illinois.
6. Support for laws which recognize marriage as an economic partnership and for a divorce process which is fair and equitable to all parties with regard to property division, maintenance, custody and child support.
7. Support for comprehensive and coordinated services for mentally ill adults and children in both state facilities and community programs.
8. Support of a public school system that is equitable both in quality for the student and financing for the taxpayer.
9. Support for a diversified and equitable revenue system that provides adequate support for state and local governments, schools, and human services, and that furthers League environmental and land use goals.
10. Establishment of a task force to develop criteria and guidelines for solid waste management based on LWVUS positions.
11. A study with concurrence on selected aspects of the structure of county government.

PRINCIPLES OF THE LEAGUE OF WOMEN VOTERS

The League of Women Voters believes in representative government and in the individual liberties established in the Constitution of the United States of America.

The League of Women Voters believes that democratic government depends upon the informed and active participation of its citizens and requires that governmental bodies protect the citizens's right to know by giving adequate notice of proposed actions, holding open meetings and making public records accessible.

The League of Women Voters believes that every citizen should be protected in the right to vote; that every person should have access to free public education which provides equal opportunity for all; and that no person or group should suffer legal, economic or administrative discrimination.

The League of Women Voters believes that efficient and economical government requires competent personnel, the clear assignment of responsibility, adequate financing and coordination among the different agencies and levels of government.

The League of Women Voters believes that responsible government should be responsive to the will of the people; that government should maintain an equitable and flexible system of taxation, promote the conservation and development of natural resources in the public interest, share in the solution of economic and social problems which affect the general welfare, promote a sound economy and adopt domestic policies which facilitate the solution of international problems.

The League of Women Voters believes that cooperation with other nations is essential in the search for solutions to world problems, and the development of international law is imperative in the promotion of world peace.

HOW THE LEAGUE FUNCTIONS

The League takes ACTION on governmental policies and measures in the public interest in conformity with principles of the League of Women Voters of the U.S. After thorough study, it provides information, influences public opinion and supports or opposes legislation. TIME FOR ACTION occurs when League members are asked to express support or opposition on a position after study and general agreement by all Leagues affected by the proposed legislation. CONSENSUS is the term used to indicate membership agreement on an issue. It is determined by the Board after evaluating membership opinion. A LEAGUE POSITION is that body of opinion expressed in consensus appropriately worded by the League Board.

Democracy Is Not A Spectator Sport
Here's a checklist of a dozen things you can do:

1. Register to vote.
2. Become informed about local, state and national issues.
3. Study candidate qualifications.
4. Distribute literature and assist in organizing candidate forums and debates.
5. Attend city council and board of education meetings.
6. Know the men and women who represent you.
7. Write letters to local aldermen, state representatives and Congressmen or women
8. Lobby for your beliefs; testify at hearings.
9. Support the League of Women Voters.
10. Participate in League-sponsored studies on topics that interest you.
11. Vote in every primary and general election.
12. Get your spouse or a friend to do Items 1-11.

Writing to Members of Congress

Few people communicate with their elected officials. Your voice is important. A letter represents the view of 100, a telegram 250. Here are some tips to make sure your letter gets the attention it deserves:

1. To set it apart from the thousands of computer generated letters that Congress gets, make your letter as personal as possible, offering your own views on a legislative issue. Often, writing in longhand as opposed to typing will cause your letter to get noticed.
2. Focus on one issue and keep the letter short, preferably no more than a page.
3. The correct salutation for the envelope to U.S. Senators or Representatives is "The Honorable ____". The correct salutation within the letter is "Dear Senator ____" or for Representatives, "Dear Mr./Ms. ____".
4. Identify yourself as a homemaker, attorney, teacher, teenager, salesperson, etc., especially as it relates to the bill you are discussing.
5. Refer to legislation by its title and try to summarize it in the letter. Not everyone in Congress is familiar with every bill.
6. Give your reasons for supporting or opposing a specific bill.
7. Telegrams called Public Opinion Messages may be sent to Congress at any time by calling Western Union at 1-800-325-6000. The charge is about \$9-\$12 depending on length.
