

Edward L. Parsons was born in Sodus, N. Y. He served during the Civil War as clerk at one of the Regimental Headquarters. William Chamberlain

(2nd President)



William Chamberlain was born on a New Hampshire farm, from which he went to New York City to make his fortune. He entered the business of importing fruit in which he prospered. Later he came to Red Hock and purchased a large tract of land, known now as the Heberle, Trow and Timpson Farms. His lands extended into the Village of Red Hook on the north side of West Market street and included the land where the homes of William H. Boice, Albert F. Kerley and A. Stickle are now located.

He was a man of great executive ability. He was one of the founders of the bank and a member of the first Board of Directors and 2nd President of the Red Hook Bank during the years 1866 to 1875.

Mr. Chamberlain was the first president of the New York Central Railroad. It was thought that his object in buying up property in Red Hook was to induce the railroad to run its tracks directly through the village. Many estates along the Hudson were bought at that time as Mr. Chamberlain gave them his guarantee that their property would not be disturbed by the tracks of the proposed railroad. However, he was out-voted in the meeting of the railroad board of directors and the road was laid out in its present location despite his efforts.

Charles B. Hoffman



Charles Beekman Hoffman was born in the town of Red Hook. He was educated in the De Carmo Institute in Rhinebeck. In early life he as a farmer and his homestead was the farm now owned by the estate of Lewis H. Mr. Weaver was also a director of the institution, having been elected to this office on May 29th, 1905.

He was president of the Dutchess County Historical Society, President of the Dutchess County Health Association and a trustee of the Rhinebeck Savings Bank. He was also associated with other organizations.

Although of an unassuming and reserved nature, he was extremely public spirited and was ever ready to render generous community service,

WILLIAM S. MASSONNEAU




Benjamin Beekman Hoffman, born in Red Hook, was one of the first stockholders of the First National Bank. He was elected a director in 1877 and was its fourth president from 1898 to 1901. Mr. Hoffman was an active business man of the village and he conducted a butcher shop in the store now occupied by Paul Fragomen. Later he was a partner in the well-known tobacco firm, Hoffman & Co. He was a careful, keen business man and added materially to the strength of the directorship of the bank. His advice was frequently sought by investors of the town.

Allan B. Hendricks, the oldest living depositor and assistant Cashier of the First National Bank from 1904 to 1918, was born in Red Hook, the son of Jeremiah Hendricks. As a young man he was engaged in the freighting business under the firm name of Allan B. Hendricks & Co., Barrytown. At one time he conducted the Red Hook Mill. Later in life he was actively associated with the affairs of the Bank, being assistant Cashier from 1904 to 1918. He has for over fifty years been a representative of several insurance companies and continues in active business at the the age of 87 years.

Mr. Hendricks' activities and interest in behalf of the bank span the whole life of the institution.
