I, Margery Armstrong McNally being of the age of eighteen years and upwards, hereby apply for membership in the Society by right of lineal descent in the following line from John (Johannes) Stickle who was born in Rhinebeck Precinct, N.Y. on the 13th day of Nov., 1743 and died in Rhinebeck Precinct, N.Y. on the 3rd day of Oct., 1816. His place of residence during the Revolution was Rhinebeck Precinct.

1. I am the daughter of Lorenzo Moray Armstrong ¹⁸⁸⁶ born on 7-17-1886 at New Haven, Conn. died at Rhinebeck, N.Y. on 10-17-1943 and his (first) wife Marjorie Hoffman born on 5-15-1885 at Red Hook, New York still living married on 10-9-1915.

2. The said Marjorie Hoffman was the child of Charles Beekman Hoffman born on 6-10-1855 at Red Hook, N.Y. died at Red Hook, N.Y. on 1-21-1921 and his (first) wife Fannie L. Allendorph born on 4-27-1860.

3. The said Fannie L. Allendorph was the child of Alfred Allendorph born on 8-17-1829 at Red Hook, N.Y. died at Red Hook, N.Y. on 2-14-1887 and his (first) wife Catherine Shook born on 7-6-1830 at Red Hook, N.Y. died at Red Hook, N.Y. on 3-13-1912 married on 10-12-1854.

4. The said Alfred Allendorph was the child of Philip Allendorph born on 1-2-1793 at Red Hook, N.Y. died at Red Hook, N.Y. on 8-3-1871 and his (first) wife Elizabeth Stickle born on 10-3-1799 at Red Hook, N.Y. died at Red Hook, N.Y. on 5-22-1884 married on 6-18-1815.

4 5. The said Elizabeth Stickle was the child of John I. Stickle, Jr. born on ¹⁸⁻³⁻¹⁷⁹⁹ 12-20-1774 at Rhinebeck Precinct died at Rhinebeck Precinct on 12-2-1871 and his (first) wife Anna Fraleigh born on 9-19-1775 at Rhinebeck Precinct (Red Hook) died at Rhinebeck Precinct (Red Hook) on 1-12-1850 married on 5-25-1794.

6. The said John I. Stickle, Jr. was the child of Johannes Stickle born on 11-13-1743 at Rhinebeck Precinct died at Rhinebeck Precinct 10-3-1816 and his (first) wife Elizabeth Bohen born on 7-31-1746 at Rhinebeck Precinct (Red Hook) died at Rhinebeck Precinct on 8-26-1827 married on 2-2-1766.

ELIGIBILITY CLAUSE

"Any woman is eligible for membership in the National Society of the Daughters of the American Revolution who is not less than eighteen years of age, and who is descended from a man or woman who, with unfailing loyalty to the cause of American Independence, served as a sailor, or as a soldier or civil officer in one of the several Colonies or States, or in the United Colonies or States, or as a recognized patriot, or rendered material aid thereto; provided the applicant is personally acceptable to the Society."
(Constitution, Article III, section I.)

Johannes Stickle, son of Nicholas Stickle and Anna Margareta Drom.

Nicholas was associator, Rhinebeck Precinct.

John was an office holder in the Rhinebeck Precinct many years. He and his wife, Elizabeth and his son, John and his wife, Anna are buried in the Lutheran Church yard, Red Hook, N.Y. village.

The said John (Johannes) Stickle is the ancestor who assisted in establishing American Independence, while acting in the Capacity of Private in Dutchess Co. Militia, 6th Regt., Land Bounty Rights.
