GRAND MUSICAL ENTERTAINMENT IN RED HOOK.

MADAME ANNA BISHOP COMING!

On Monday evening, a large number of the prominent citizens of this village, Upper Red Hook, Barrytown, and the adjacent country, might have been seen assembling at the Red Hook Hotel, and upon inquiry it was ascertained that a matter of no little moment to the inhabitants of this vicinity was under consideration.

On Motion Orison Graves Esq. was called to the Chair, and Robert B. Hevenor and Daniel A. Cuck were ap-

pointed Secretaries.

After the meeting was thus organized J. W. Elseffer Esq. was called upon, and with his usual fluency stated the object

of the meeting.

Mr. Elseffer said:—The late brief visit to this place of the distinguished vocalist Madame Anna Bishop with her Husband Mr. Martin Schultz, had suggested to the public mind the propriety of soliciting from her a concert

at this village.

He had the pleasure of informing the meeting that in about ten days the Lady to whom he referred, expected again to visit relatives of her Husband in this vicinity, which occasion it was thought might furnish an opportunity of listening to her clarion voice, provided arrangements are made of a character to be agreeable to her. The meeting now assembled he thought gave evidence of considerable spirit in that direction, and he had the pleasure to say that in an interview with the Lady a few evenings since, in reply to a suggestion on this subject, she had deferred entirely to the wishes of her Husband in that respect; and he would not dissent from the desires of numerous acquaintances and friends in this vicinity. It remained, he thought, with those now present to determine in reference to an entertainment of this character—for his own part he would gladly and cheerfully favor all suitable arrangements having this object in view.

After some further remarks, it was unanimously Resolved That Madam Anna Bishop be solicited to give a Ticket Concert at the Village of Red Hook at such time as would be most convenient to her.

A committee consisting of Andrew Crane, Alfred Allendorf, and Peter G. Fraleigh was thereupon appointed, for the purpose of waiting on the Trustees of the Lutheran Church in reference to

the object in view.

On Motion a Committee of threewas appointed to be denominated a Committee on publication, to wit: Doct. Bates, Augustus Martin and Jer-

emiah Hendricks.

On Motion the following named Gentlemen were requested to serve as a Committee, with reference to necessary preparations at the Church and the

preservation of order.

On motion the proceedings of the meeting were directed to be published

in the Red Hook Journal.

The meeting was then adjourned to Saturday Evening the 24th inst. at 7 o'clock at the same place for the purpose of making further arrangements in reference to the Grand Concert, in case a favorable answer be received from Madam Anna Bishop.
