Only 47 people will be able to take advantage of this very special opportunity to tour one of the Hudson Valley's most famous restorations which, being a private residence, is rarely open to the public. Through the generosity of its present owner, Mr. Richard Jenrette, our group will be able to have a first hand view of this home which Antique Magazine has called "one of the most dazzling restoration in America."

"Edgewater" is a majestic neo-classical house built ca. 1820 in the Village of Barrytown, New York. Since the time of its construction, the house has changed owners a number of times. The present owner, Mr. Richard Jenrette of New York City and Barrytown, since buying the house from Gore Vidal in 1969, has devoted himself to recreating the magnificence and opulence that once was part of its history. In furnishing the rooms, Mr. Jenrette used an 1872 inventory as a guide, supplementing the original furniture he tracked down with pieces of comparable style and elegance - most of them by early 19th century New York cabinetmakers.

The house at "Edgewater" is a meticulous restoration and is filled with furniture, decorative arts and paintings of museum quality. The elegance of this home is reflected by the thirteen years of painstaking research that brought Mr. Jenrette and his staff across the county and half way around the world in search of the original furniture that once occupied a special place within the house.

Our day will begin with a full guided tour of this grand home on the banks of the Hudson River. Visitors will be led from room to room by a member of the house staff who is well versed in the history of the furniture and decorative arts of the home. After our inside tour, you will be free to roam the estate grounds and decide perhaps to picnic along the Hudson River on the boxed lunches which will be provided each person.

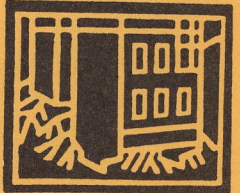
