

ORDINANCES.

PASSED DECEMBER 15, 1874.

THE BOARD OF TRUSTEES OF THE VILLAGE OF
TIVOLI, DO ORDAIN AS FOLLOWS:

VILLAGE ORDINANCE No. 27.

*An Amended Ordinance relating to the throwing of
garbage or any refuse matter in the streets of the Vil-
lage of Tivoli:*

Village Ordinance No. 4 passed August 22, 1872, is hereby amended so as to read as follows:

SECTION 1. No person or persons shall throw, place, or collect in any of the streets of said Village, except under the direction of the Street Commissioner, any manure, dirt, filth, offal, or any refuse matter or rubbish of any description.

§ 2. No person or persons shall throw any slops, wash or filthy water in any drain or sluiceway leading or which may lead said slops, wash or filthy water in the street, or any drain of said Village.

§ 3. Any person violating any or either of the provisions of this Ordinance shall incur a penalty of \$5.00 for each and every offence.

§ 4. All ordinances and part of ordinances in conflict herewith are hereby repealed.

VILLAGE ORDINANCE No. 28.

An Amended Ordinance to regulate Auction Sales.

Village Ordinance No. 7, passed August 22, 1872, is hereby amended so as to read as follows:

SECTION 1. All Auction Sales are hereby forbidden in said Village unless in each case the person or persons intending to conduct such sale shall apply for and obtain a license in writing from the President or Clerk of said Village, to be previously had and obtained for which license so to be granted the person or persons so applying shall pay, for the use and benefit of the Village for such sale as follows: For three days or less the sum of three dollars, for a longer period than three days and not exceeding ten, five dollars; and for every additional day exceeding ten, fifty cents.

§ 2. No owner or occupant of any house, out house, yard, shed or other place shall furnish or allow the same to be used for any such Auction Sale unless the person or persons proposing to conduct such sale shall first

have and obtained a license in writing from the President or Clerk of the Village for such sale, specifying the time for which the same shall be allowed.

§ 3. Any person offending against or violating any or either of the provisions of this ordinance shall forfeit and pay the sum of Twenty Dollars to be sued for and recovered by said village for its use and benefit. But this ordinance shall not apply to sales under legal process, or chattel mortgages, or to sales by the head of a family breaking up housekeeping or removing of his or her household goods.

§ 4. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.

VILLAGE ORDINANCE No. 29.

An Amended Ordinance to regulate bathing in the ponds and streams of the Village.

Village Ordinance No. 8, passed September 5, 1872, is hereby amended so as to read as follows :

SECTION 1. It shall not be lawful for any person or persons to bathe in any pond, dam or stream of water within the limits of the Village of Tivoli, when such person or persons will be exposed to the view of travelers upon the highway or any road or street, or where they may be within view of any dwelling house ; any person violating any or either of the provisions of this ordinance shall forfeit and incur a penalty of three dollars.

§ 2. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.

VILLAGE ORDINANCE No. 30.

An Amended Ordinance to regulate riding and driving in the streets, &c.

Village Ordinance No. 9, passed September 5, 1872, is hereby amended so as to read as follows :

SECTION 1. No person or persons shall ride on horseback or drive any horse or horses, mule or mules, in any cart, wagon, chair, chaise, gig, coach, sleigh, sled or other carriage in any of the streets of said village, immoderately or with greater speed than a slow trot or pace, not exceeding the rate of seven miles per hour. Any person violating any or either of the provisions of this section shall forfeit and incur a penalty of five dollars ; and all police officers are hereby authorized to stop any person or persons in the act of violating any of the provisions of this section.

§ 2. No person or persons shall leave any horse or horses untied in the streets of the village of Tivoli. Any person violating any or either of the provisions of this section shall forfeit and incur a penalty of three dollars.

§ 3. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.

VILLAGE ORDINANCE No. 31.

An Amended Ordinance to prevent the throwing of stones and other missiles in the streets.

Village Ordinance No. 10, passed September 5, 1872, is hereby amended so as to read as follows:

SECTION 1. It is hereby forbidden to throw stones, ice or snowballs, or any other missiles in the streets of the village of Tivoli.

§ 2. Ball playing in the streets of said village and in the neighborhood of dwellings is hereby forbidden. Any person violating any or either of the provisions of this ordinance shall forfeit and incur a penalty of three dollars.

§ 3. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.

VILLAGE ORDINANCE No. 32.

An Amended Ordinance to secure the removal of snow and ice from the sidewalks in the Village of Tivoli.

Village Ordinance No. 11, passed November 28, 1872, is hereby amended so as to read as follows:

SECTION 1. It is hereby ordained that the owner or owners, occupant or occupants of any lot or lands in front of or adjoining which a sidewalk has been or shall be made in said village, shall keep such sidewalk clear and free from snow and ice, and after every snowfall such walks shall be cleared within a reasonable time by such owner or owners, occupant or occupants. Any person violating any or either of the provisions of this section, shall forfeit and incur a penalty of five dollars, And in addition thereto the Street Commissioner is empowered to cause such sidewalks to be cleaned and the cost of such cleaning shall constitute a lawful charge against such owner or owners, occupant or occupants, and may be collected by action against them or either of them.

§ 2. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
