The march began outside St. Brigida's church about 9 p.m. after a Mass celebrated by about 8,000 supporters, friends and relatives of Walesa, who like other union leaders has been interned since the start of martial law Dec. 13.

Witnesses said a crowd of about 1,000 then began marching toward a monument. The crowd planned to lay flowers at the monument, but was blocked by police lines.

Gdansk suffered far more serious incidents including riots on Aug. 13 and 31 and during the early days of martial law. Riots and protests on Aug. 31 swept Gdansk and scores of other Polish towns.

Walesa led the August 1980 shipyard strikes in Gdansk that led to the formation of Solidarity, the only independent union in the Soviet bloc.

Walesa has been held since May in a remote government resort house near the Polish-Soviet border south of Przemysl.

Green River Police arrived at the home of William Linton, 42, to find him and his wife Alice Marie Linton, 39, dead. Green River Police Chief Reed Hayes said this morning the shootings took place about 10:30 p.m. Sunday, apparently following an argument. The coroner ruled the case a murder-suicide.

"A neighbor heard an argument next door and then heard shots," Hayes said. called the police, and when we got there, we found them both dead. He (Linton) had been out of work for a couple of weeks, so that possibly had something to do with it."

The Lintons had lived in Green River for one year.

A native of Lorain, Mrs. Linton attended St. Stanislaus School, and graduated in 1961 from Lorain High School. She majored in home economics at Ohio University in Athens and

graduated from there in 1965. She taught at John Marshall High School, Cleveland, and also high schools in Sandusky and Toledo. She had taught in St. Louis, Mo. for six years before moving to Green River, where she was a substitute teacher.

Mrs. Linton was a member of Immaculate Conception Catholic Church, Green River, St. Ann Lodge Br. 75 of Lorain, and was a former member of St. Stanislaus Church.

Survivors include her parents, Henry and Mildred Rogalski of Lorain.

Friends may call today, 2 to 4 and 7 to 9 p.m., at the John K. Dovin Funeral Home, 2701 Elyria Ave., Lorain, where a Rosary service conducted by St. Ann Lodge will be at 7:30 p.m. Rites will be at 12:45 p.m. tomorrow in the funeral home, followed by 1 p.m. Mass at St. Stanislaus Church. The Rev. Michael Dyrcz, pastor, will officiate. Burial will be in Calvary Cemetery, Lorain.

Ex-IRS chiefs benefits of flat

By The Associated Press WASHINGTON — Two for-mer Internal Revenue Service mer Internal Revenue Service commissioners say a single-rate income tax for everyone would only simplify the tax system if there is a wholesale elimination of credits and

The former tax collectors, Sheldon S. Cohen and Jerome Kurtz, agreed with growing complaints that the income tax has become too complex and filled with inequities.

But they cautioned against substituting a single- or flat-rate tax for the progressive system that is based on ability to pay.

"If we are seduced into believing that simplification requires a flat rate, we will unnecessarily sacrifice substantial equity for minimal gains in simplification," Kurtz told the Senate Finance Committee yesterday.

Added Cohen: "Virtually all of the promised simplification in the flat-tax proposal arises from eliminating the bulk of. the deductions, credits and so on now found in the income

Hurricane Paul leaves five dead

LA PAZ, Mexico — Hurricane P.
slammed into northwest Mexico today, packing 112 mph gusts and herains that reportedly left at least people dead, damaged homes and telephone service along the coast of Gulf of California.

The national weather service in Mex City said the vanguard of the sto passed over the Baja California pening late yesterday and smashed into mainland's Sonora state in the ca morning hours, heading north-northat 14 mph.

The Red Cross in La Paz, state capital South Baja California, said the winds w felt since noon yesterday. A spokesn who did not give his name, said about homes were damaged by the winds heavy rains.

Mexican television stations said at le five people were killed as the stravaged Baja, but the Red Cross sporman said he could not confirm any deaths.

He also said late yesterday telephone communications to San Jose Cabo, about 70 miles south of here on peninsula's tip, had been interrupted
